Bearings are based on the West line of the Northeast Quarter of Section 29 bearing North $00^{\circ}16'00''$ West.

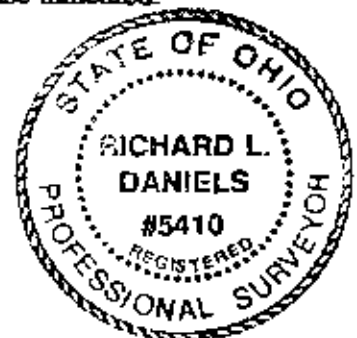

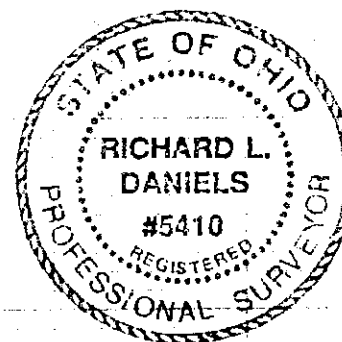
