

**DESCRIPTION OF SURVEY FOR OHIO FRANKLIN REALTY, LLC
JOB#2501 SECTION 33-1**

Situated in the State of Ohio, County of Muskingum, Township of Meigs:

Being part of Section 33, Township 12, Range 11, of the Congress Lands East of the Scioto River, further **being part of** the Ohio Franklin Realty, LLC property recorded in **Official Record Volume 2594, Page 344** of said county's deed records, further **being part of** Muskingum County Auditor's Parcel Number **40-80-33-01-000** and more particularly described as follows;

Beginning at a stone (found) at the common corner for Sections 28, 29, 32, and 33 of said Township and Range, further being the Southeast corner of Tract 21 of the Shook Farm Subdivision recorded in Plat Book 18, Page 65;

- #1- **THENCE South 87 degrees 22 minutes 10 seconds East 5359.98 feet** along the common line for Sections 28 and 33 and through said Ohio Franklin Realty, LLC property to a calculated common corner for Sections 27, 28, 33, and 34 of said Township and Range, passing the centerline of Young Hickory Road (County Road 223) at 3512.52 feet;
- #2- **THENCE South 01 degrees 54 minutes 04 seconds West 462.99 feet** along the common line for Sections 33 and 34, continuing through said property to an unmarked point on a line of a Corridor surveyed from said Ohio Franklin Realty, LLC property and to date not recorded;
- #3- **THENCE North 87 degrees 07 minutes 16 seconds West 4013.83 feet** into Section 33 and continuing through said property to an iron pin (set), passing the centerline of Young Hickory Road at 2006.65 feet;
- #4- **THENCE South 41 degrees 52 minutes 55 seconds West 2097.83 feet** continuing through said property to an aluminum monument (set) on the common line for Sections 32 and 33;
- #5- **THENCE North 01 degrees 56 minutes 45 seconds East 2070.23 feet** along said Section line and common line for said Ohio Franklin Realty, LLC property and for the Rodney E Dingey properties recorded in Deed Book Volume 1058, Page 549 and Deed Book Volume 1023, Page 398 to the place of beginning, **containing 80.74 acres**, of which 0.44 acres are within the right of way for Young Hickory Road (County Road 223).

The bearings and distances within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. See Plat for META Data. Aluminum monuments (set) are 2" break off capped ODNR Survey Mark. Iron pins (set) are 3/4" rebar capped ODNR Survey Boundary Marker PLS #6885.
