thence N. 01 deg. 29'42" E. along said quarter, quarter section line, a distance of 279.09 feet to set roof bolt,

thence N. 01 deg. 29'42" E. along said quarter, quarter section line, a distance of 220.75 feet to a set roof bolt,

thence S. 72 deg. 26'00" E. along the Lloyd McCoy lands as recorded in Volume 543, Page 100, a distance of 28.36 feet to a found "T" shaped iron rail,

thence S. 10 deg. 35'44" E. along said McCoy lands, a distance of 439.02 feet to a found "T" shaped iron rail located on the north right of way line of State Route 93,

thence S. 63 deg. 45'02" W. along said north right of way line, a distance of 134.69 feet to the true place of beginning.

thence N. 63 deg. 45'02" E. along said south right of way line, a distance of 234.56 feet to a set roof bolt located on the west right of way line of Township Road 174,

thence S. 24 deg. 32'59" E. along said west right of way line, a distance of 143.56 feet to a point,

thence S. 21 deg. 31'11" E. along said west right of way line, a distance of 75.93 feet to a point,

thence S. 19 deg. 45'13" E. along said west right of way line, a distance of 211.32 feet to a point,

thence S. 22 deg. 52'29" E. along said west right of way line, a distance of 63.83 feet to a point,

thence S. 28 deg. 38'12" E. along said west right of way line, a distance of 49.70 feet to a point,

thence S. 35 deg. 21'10" E. along said west right of way line, a distance of 41.42 feet to a point,

thence S. 39 deg. 53'23" E. along said west right of way line, a distance of 133.60 feet to a point,
