Description for Joe Wolfe in Monroe Township, Muskingum County, Ohio.

Being a tract of land in the Northeast Quarter of Section 10, First Quarter, Range 5W, Township 3N, Monroe Township, Muskingum County, State of Ohio, and being further described as follows;

Note: North based on a survey by T.W. Taylor, Dec. 28, 1999. All steel pins indicated as recovered are 3/4" rebar with plastic caps marked "T.W. Taylor 7053".

Research Data: Deeds, surveys and plats of record.

Beginning at a point on the South Right-of-Way line of Township Road 173 (Houts Road) and on the East line of Muskingum County, said point being located from a steel pin recovered at the Northeast corner of said Section 10 by the following two (2) courses;

1. with the said East line of Muskingum County, South 1 degree 31' 20" West, a distance of four hundred ninety and ninety-three hundredths (490.93) feet to a recovered steel pin;
2. continuing with the said East line of Muskingum County and continuing South 1 degree 31' 20" West, a distance of six and ninety-six hundredths (6.96) feet to the said beginning point;

thence, continuing with the said East line of Muskingum County and continuing South 1 degree 31' 20" West, a distance of one thousand two hundred fifteen and twenty-seven hundredths (1215.27) feet to a recovered steel pin;

thence, with the lands of Holmes Limestone Co. (O.R. 1151/657, Tract 8, Parcels 1 & 2) the following two (2) courses;

1. North 88 degrees 28' 15" West, a distance of one hundred ninety-eight and nine hundredths (198.09) feet to a recovered steel pin;
2. North 1 degree 32' 31" East, a distance of one thousand one hundred forty-eight and fifty-one hundredths (1148.51) feet to a point on the said South Right-of-Way line of Township Road 173, said point being located South 1 degree 32' 31" West, a distance of six and twenty-five hundredths (6.25) feet from a recovered steel pin;

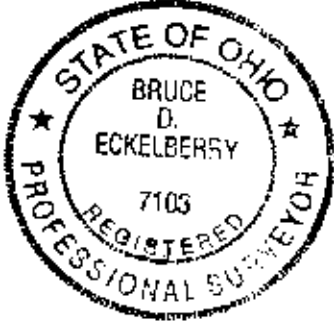
thence, with the said South Right-of-Way line of Township Road 173 the following two (2) courses;

1. North 77 degrees 35' 59" East, a distance of eighty-three and five hundredths (83.05) feet to a point;
2. North 69 degrees 45' 13" East, a distance of one hundred twenty-six and eight hundredths (126.08) feet to the point of beginning;

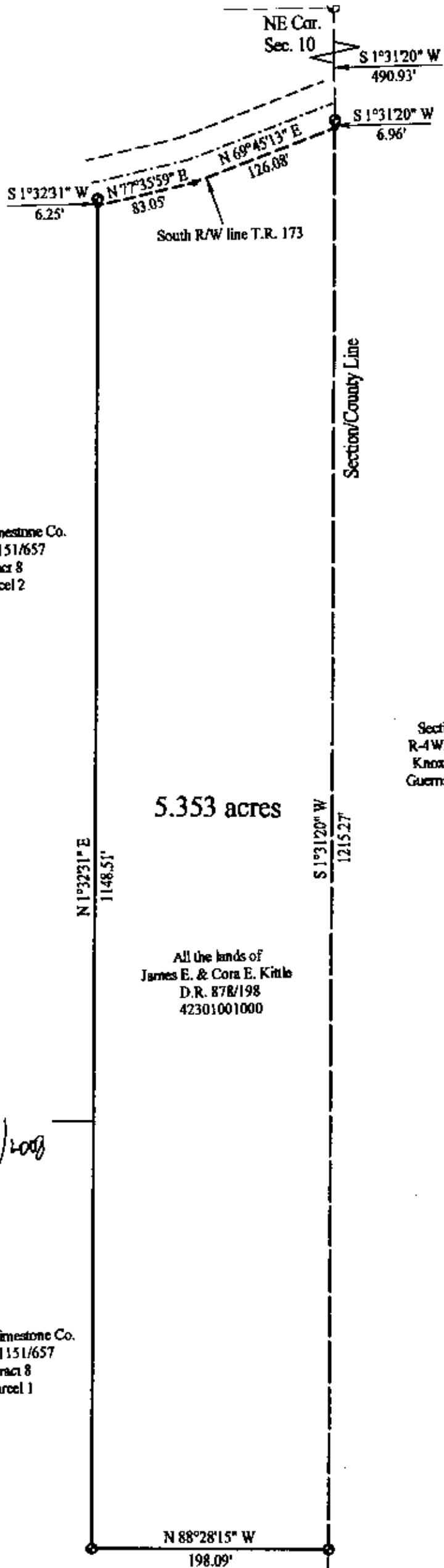
