BEING A PART OF LOT SEVEN AND A PART OF LOT EIGHT OF THE THIRD QUARTER OF THE FIRST TOWNSHIP, RANGE 5, OF THE UNITED STATES MILITARY LANDS, MONROE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING STONE AT THE NORTHWEST CORNER OF THE EAST HALF OF SAID LOT SEVEN; THENCE NORTH 89 DEGREES 29 MINUTES 18 SECONDS EAST 877.00 FEET ALONG THE NORTH LINE OF SAID LOT SEVEN TO AN IRON PIN SET AT THE NORTHWEST CORNER OF A 0.30 MORE OR LESS ACRE TRACT; THENCE SOUTH 19 DEGREES 08 MINUTES 44 SECONDS EAST 59.80 FEET TO AN IRON PIN SET AT THE SOUTHWEST CORNER OF SAID 0.30 MORE OR LESS ACRE TRACT; THENCE SOUTH 63 DEGREES 37 MINUTES 44 SECONDS EAST 94.14 FEET ALONG THE SOUTH LINE OF SAID 0.30 MORE OR LESS ACRE TRACT TO AN IRON PIN SET ON THE WEST LINE OF THE 6.58 MORE OR LESS ACRE TRACT CONVEYED TO WALTER S. LITTLE BY DEED VOLUME 723, PAGE 233; THENCE SOUTH 01 DEGREES 01 MINUTES 26 SECONDS EAST 86.13 FEET ALONG THE WEST LINE OF SAID 6.58 MORE OR LESS ACRE TRACT TO A POINT ON THE WEST RIGHT-OF-WAY LINE OF STATE ROUTE 83; THENCE SOUTH 14 DEGREES 47 MINUTES 09 SECONDS WEST 87.99 FEET TO A POINT ON SAID RIGHT-OF-WAY, SAID POINT BEING SOUTH 30 DEGREES 39 MINUTES 40 SECONDS EAST 0.72 FEET FROM AN IRON PIN SET; THENCE SOUTH 18 DEGREES 08 MINUTES 34 SECONDS WEST 111.85 FEET TO A POINT ON SAID RIGHT-OF-WAY, SAID POINT BEING SOUTH 89 DEGREES 29 MINUTES 18 SECONDS WEST 39.88 FEET FROM A RAIL ROAD SPIKE SET IN THE CENTER OF SAID STATE ROUTE 83; THENCE LEAVING SAID RIGHT-OF-WAY SOUTH 89 DEGREES 29 MINUTES 18 SECONDS WEST 1485.76 FEET TO A POINT IN THE CENTER OF STATE ROUTE 93, PASSING AN IRON PIN SET AT 1428.01 FEET; THENCE NORTH 41 DEGREES 58 MINUTES 44 SECONDS EAST 72.26 FEET ALONG SAID CENTER TO AN EXISTING P-K NAIL; THENCE NORTH 28 DEGREES 45 MINUTES 25 SECONDS EAST 348.39 FEET ALONG SAID CENTER TO AN EXISTING P-K NAIL ON THE NORTH LINE OF LOT SEVEN; THENCE LEAVING SAID ROAD AND ALONG THE NORTH LINE OF LOT SEVEN NORTH 90 DEGREES 00 MINUTES 00 SECONDS WEST 283.91 FEET TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 25.00 FEET; THENCE LEAVING SAID LOT LINE NORTH 30 DEGREES 49 MINUTES 54 SECONDS EAST 443.50 FEET TO AN IRON PIN SET; THENCE SOUTH 81 DEGREES 17 MINUTES 03 SECONDS EAST 204.23 FEET TO A POINT IN THE CENTER OF SAID STATE ROUTE 93, PASSING AN IRON PIN SET AT 188.73 FEET; THENCE ALONG THE CENTER OF SAID STATE ROUTE 93 THE NEXT FIVE COURSES AND DISTANCE:

- 1) NORTH 23 DEGREES 48 MINUTES 39 SECONDS EAST 120.71 FEET TO A POINT,
- 2) NORTH 22 DEGREES 42 MINUTES 44 SECONDS EAST 52.55 FEET TO A POINT,
- 3) NORTH 21 DEGREES 00 MINUTES 19 SECONDS EAST 53.93 FEET TO A POINT,
- 4) NORTH 19 DEGREES 29 MINUTES 38 SECONDS EAST 53.60 FEET TO A POINT,
- 5) NORTH 18 DEGREES 33 MINUTES 31 SECONDS EAST 29.52 FEET TO A POINT ON THE EAST LINE OF THE WEST HALF OF LOT 8; THENCE LEAVING SAID ROAD AND ALONG SAID EAST LINE SOUTH 00 DEGREES 40 MINUTES 25 SECONDS EAST, PASSING AN IRON PIN SET AT 125.81 FEET, A TOTAL DISTANCE OF 570.53 FEET TO THE PLACE OF BEGINNING.

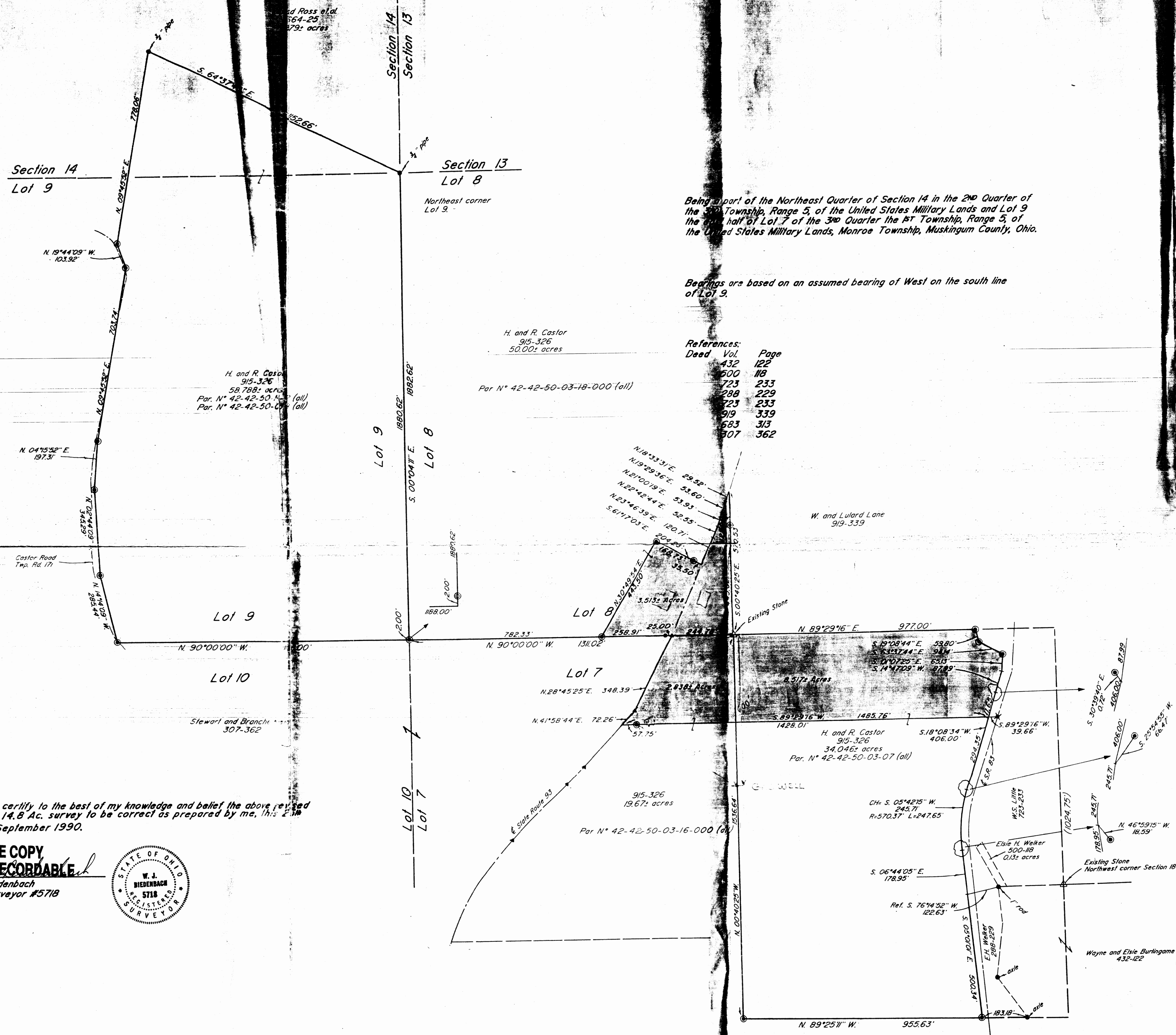

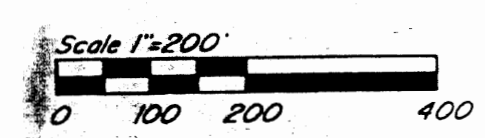
