Matchett, DR 641-90, (all,), Parcel No. 42-50-03-33-000 (all, 102.000 Ac.) and Parcel No. 42-50-03-37-000 (all, 89.440) more particularly described as follows:

Commencing at a stone found at the Southeast corner of Lot 13, said stone being the TRUE POINT OF BEGINNING;

thence, with the property line of Jacob Y. Zook Jr. and Annie K. Zook, DR 3129-806 and the North line of Lot 14, N. 87° 54' 36" W. a distance of 1140.36' to a $\frac{5}{8}$ " rebar found;

thence, with the property line of Harold Burlingame, Jerry Burlingame and Jean Wye, OR 1083-373 and OR 1689.818 and the West line of Lot 5, S. 02° 17' 43" W. a distance of 1569.97' to a $\frac{5}{8}$ " rebar found;

thence, with the property line of Jonas L. and Fannie J. Schlabach, OR 2670-822 and the West line of Lot 4, S. 01° 51' 59" W. a distance of 1716.41' to the TRUE POINT OF BEGINNING, containing, 191.440 acres, more or less and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied including public road right-of-way.
