Being a part of the Southwest quarter of section 6, township 2, North; range 8, West, Muskingum township, Muskingum county, State of Ohio and being apart of the tract last transferred to Loren C. and Evelyn M. Camp as recorded in deed book 922 page 348 of the said county records and being further described as follows.

Beginning for reference at a stone found at the Southwest corner of section 6, Thence along the south line of section 6, South 87 degrees 08 minutes 58 seconds East 1718.10 feet to an iron pin set in prior road, said pin being the place of beginning for the tract herein described. Thence leaving said prior road and with a new line North 11 degrees 33 minutes 07 seconds West 100.22 feet to an iron pin set. Thence North 77 degrees 57 minutes 19 seconds East 405.59 feet to an iron pin set in the West line of a 1.19 acre tract recorded in deed book 1000 page 141, passing an iron pin set at 276.35 feet. Thence along the said West line South 03 degrees 19 minutes 35 seconds West 201.34 feet to a point in Prior road, passing an iron pin found at 181.34 feet. Thence along prior road North 87 degrees 08 minutes 58 seconds West 365.37 feet to the place of beginning containing 1.3109 acres more or less. Subject to all Easements and right-of-ways either written or implied. All iron pins set are 5/8 inch by 30 inch rebar with I.D. caps stamped "Walton S-7675. Bearings based on a previous survey by, W.J. Biedenbach dated 4-12-94 and are for angular calculation only. Description prepared by Steven B. 




