LEGAL DESCRIPTION**

**PARCEL ONE**

Situated in the State of Ohio, Muskingum County, Muskingum Township, South half of Quarter Township 2, Range 8, being part of the South West Quarter of Section 8, and more particularly described as follows:

Beginning at a stone at the south west corner of the south west quarter of Section 8;

thence with the Section line North 00 degree 00 minutes East a distance of 739.30 feet to a point on the section line and in the center line of State Route 60;

thence with the center line of State Route 60 North 65 degrees 47 minutes East a distance of 239.41 feet to a point in the intersection of State Route 60 and the center line of County Road No. 116, McGlade School Road;

thence with the center line of County Road 116, McGlade School Road the following 4 courses and distances:

North 60 degrees 55 minutes East a distance of 210.77 feet;

North 55 degrees 26 minutes East a distance of 308.95 feet;

North 60 degrees 55 minutes East a distance of 242.48 feet;

North 63 degrees 24 minutes East a distance of 282.50 feet to a point; said point being the true place of beginning for the tract herein to be described;

thence continuing North 63 degrees 24 minutes East a distance of 100.00 feet to a point;

thence leaving the center line of said road North 3 degrees 58 minutes East a distance of 220.00 feet to an iron pin set; passing through an iron pin set at 25.00 feet;

thence South 63 degrees 24 minutes West 100.00 feet to an iron pin set;

thence South 3 degrees 58 minutes West 220.00 feet, passing through an iron pin set at 195.99 feet, containing .505 acres more or less.

thence with the Section line North 00 degree 00 minutes East a distance of 739.30 feet to a point on the section line and in the center line of State Route 60;

thence with the center line of State Route 60 North 65 degrees 47 minutes East a distance of 239.41 feet to a point in the intersection of State Route 60 and the center line of County Road 116;

thence with the center line of County Road 116, McGlade School Road the following 4 courses and distances:

North 60 degrees 55 minutes East a distance of 210.77 feet;

North 55 degrees 26 minutes East a distance of 306.95 feet;

North 60 degrees 55 minutes East a distance of 242.48 feet;

North 63 degrees 24 minutes East a distance of 382.50 feet to a point, said point being the true place of beginning for the tract herein described;

thence continuing North 63 degrees 24 minutes East a distance of 100.00 feet to a point;

thence leaving the center line of said road North 3 degrees 58 minutes East a distance of 220.00 feet to an iron pin set, passing through an iron pin at 25.00 feet;


thence South 63 degrees 24 minutes West 100.00 feet to an iron pin set;
