44-06-61-16-000 (15.00 Acres)

Situated in Lot 29, Quarter Township 1, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of the lands of Carol Goff conveyed in Deed book 1764 page 252 of the Muskingum County Deed records, being described as follows:

Beginning at a stone found marking the Southeast corner of Lot 29;

Thence, **S.89°52'03"W.** a distance of **661.95 feet** along the South line of said lot to a found iron pin on the Northwest corner of lot 17 of Saddlebrook Subdivision, also being the Southeast corner of a 15.00 acre parcel;

Thence, **N.00°07'57"E.** a distance of **994.51 feet** through the lands of C. Goff (1764/252) to a set rebar, passing a found iron pin at 466.57 feet;

Thence, **N.89°52'02"E.** a distance of **651.91 feet** through said Goff lands to A set rebar on the East line of Lot 29;

Thence, **S.00°26'46"E.** a distance of **994.52 feet** along said lot line to the place of beginning.

The above described parcel contains 15.00 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.
