Beginning for reference and the principal place of beginning, at the Northeast corner of Lot 6, of Plow Share Acres Subdivision, (Pl. Bk. 12, Pg. 62, and 63), and being a point on the west right of way of Winter Wood Drive, (Twp. Rd. 1515), from which an iron pipe found bears South 87 degrees 59 minutes 41 seconds East, 0.22 feet;

Thence along the east line of said Lot 6, and the west right of way of Winter Wood Drive, (Twp. Rd. 1515), South 02 degrees 20 minutes 17 seconds West, 260.05 feet to a point on the Southeast corner of Lot 6, from which an iron pipe found bears South 88 degrees 00 minutes 20 seconds East, 8.25 feet;

Thence along the south line of said Lot 6, the following two courses:

- 1.) North 88 degrees 00 minutes 20 seconds West, 378.50 feet to an iron pipe found;
- 2.) North 87 degrees 56 minutes 24 seconds West, 183.37 feet to a point in the centerline of a stream, passing an iron pin set at 174.08 feet;

Thence through said Lot, and along the centerline of said stream, the following four courses:

- 1.) North 07 degrees 20 minutes 41 seconds East, 105.08 feet to a point;
- 2.) North 12 degrees 39 minutes 21 seconds East, 82.50 feet to a point;
- 3.) North 60 degrees 42 minutes 44 seconds East, 49.96 feet to a point;
