Being part of Military Lots 21 and 22, Township 2, Range 8, of the US Military District, Containing 56.53 Acres, being part of the Ray Thomas Lumbertown property recorded in Deed Book Volume 833, Page 319, and further being part of Muskingum County Auditor's Parcel Number 44-22-01-09-000:

The undersigned, being the owner of the lands herein platted, does hereby dedicate the streets and easements as shown hereon to the public use forever.

The easements shown on this plat, unless designated for a specific purpose, are for the construction, operation, maintenance, repair, replacement or removal of water, sewer, gas, electric, telephone, cable television, or other utility lines or services, storm water disposal and for the express privilege of cutting, trimming or removing any and all trees or other obstructions within said easement, or immediately adjacent thereto, to the free use of said easements or adjacent streets and for providing ingress and egress to the property for said purposes and are to be maintained as such forever.

No buildings or other structures may be built within said easements, nor may the easement area be physically altered so as to (1) reduce clearances or either overhead or underground facilities; (2) impair the land support of said facilities; (3) impair ability to maintain the facilities; or (4) create a hazard. The above public utility easements are for the benefit of all public utility service providers including, but not limited to any and all public utilities.

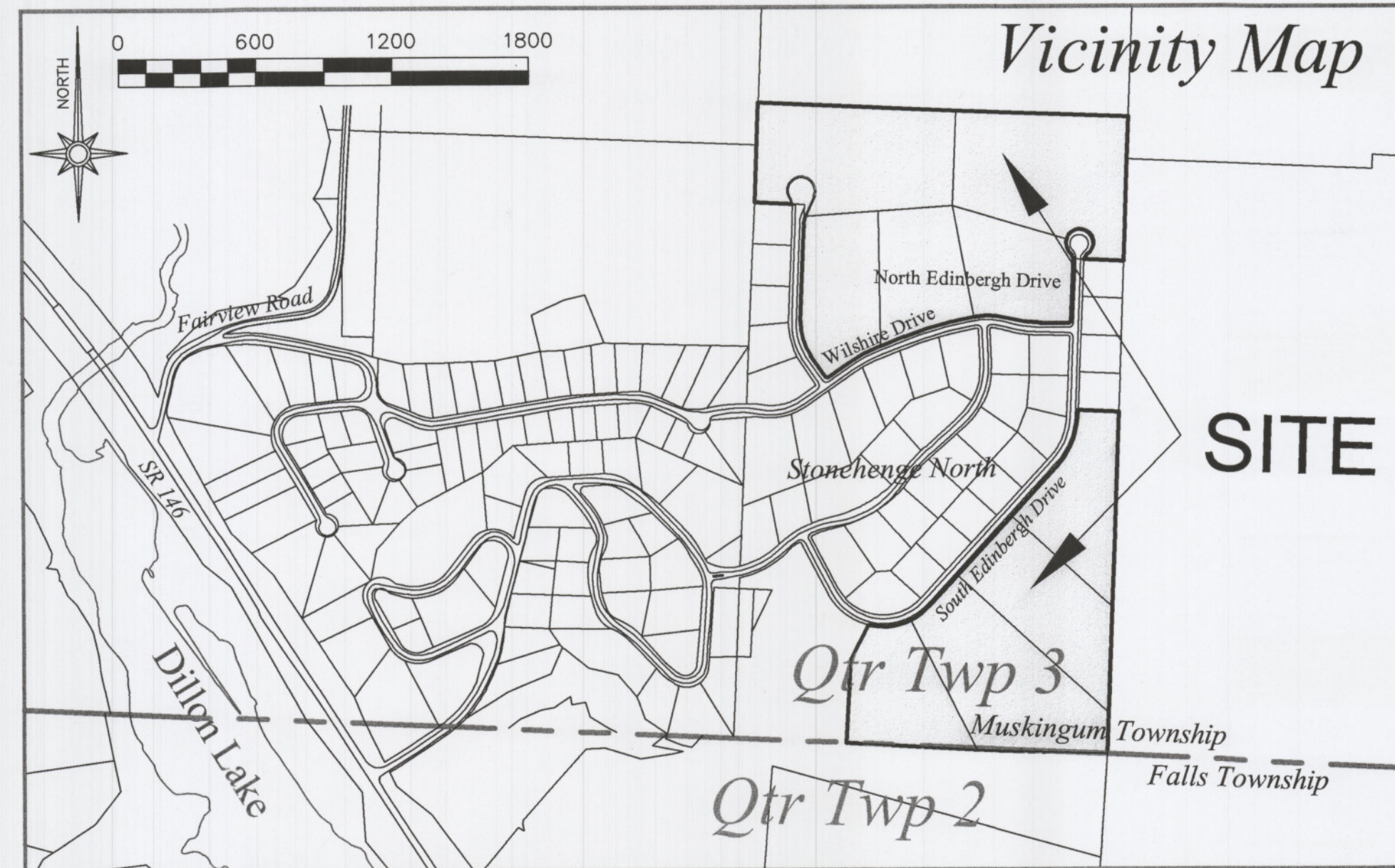

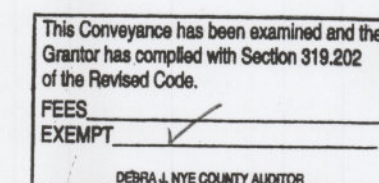
