BEING A PART OF THE 22.237 MORE OR LESS ACRE TRACT CONVEYED TO TANCO BY DEED RECORDED IN VOLUME 1102 PAGE 464 OF THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN THE SOUTHWEST QUARTER OF SECTION 22, TOWNSHIP 2, RANGE 8, OF THE UNITED STATES MILITARY LANDS, MUSKINGUM TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING STONE MARKING THE SOUTHEAST CORNER OF THE SAID SOUTHWEST QUARTER; THENCE WITH THE SOUTH LINE OF THE SAID SOUTHWEST QUARTER AND THE SOUTH LINE OF MUSKINGUM TOWNSHIP, NORTH 89 DEGREES 30 MINUTES 09 SECONDS WEST 296.56 FEET TO AN IRON PIN SET; THENCE LEAVING SAID SOUTH LINE OF THE SAID SOUTHWEST QUARTER AND TRAVERSING THROUGH THE ABOVE MENTIONED TANCO TRACT NORTH 00 DEGREES 06 MINUTES 37 SECONDS WEST 216.70 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF MAPLE CREEK DRIVE; THENCE WITH THE SOUTH LINE OF MAPLE CREEK DRIVE ON A CURVE TO THE RIGHT HAVING A RADIUS OF 25.00 FEET (CHORD BEARING SOUTH 59 DEGREES 41 MINUTES 10 SECONDS EAST 18.94 FEET) AN ARC DISTANCE OF 19.43 FEET TO AN IRON PIN SET; THENCE WITH THE SOUTH LINE OF MAPLE CREEK DRIVE ON A CURVE TO THE LEFT HAVING A RADIUS OF 50.00 FEET (CHORD NORTH 71 DEGREES 32 MINUTES 12 SECONDS EAST 94.57 FEET) AN ARC DISTANCE OF 123.97 FEET TO AN IRON PIN SET; THENCE LEAVING SAID MAPLE CREEK DRIVE SOUTH 89 DEGREES 30 MINUTES 10 SECONDS EAST 190.73 FEET TO AN IRON PIN SET ON THE EAST LINE OF SAID TANCO TRACT; THENCE ALONG SAID EAST LINE OF SAID TANCO TRACT SOUTH 00 DEGREES 02 MINUTES 41 SECONDS EAST 238.01 FEET TO THE PLACE OF BEGINNING.



