

- 3) WITH A CURVE TO THE LEFT HAVING A RADIUS OF 116.98 FEET (CHORD BEARING NORTH 02 DEGREES 58 MINUTES 02 SECONDS EAST 33.30 FEET) AN ARC DISTANCE OF 33.41 FEET TO AN IRON PIN SET;


