

Description for David Denham

Being a part of the Southeast quarter of section 2, Township 17, North; Range 15, West, Newton Township, Muskingum County, State of Ohio and being a part of the tract last transferred to David Denham as recorded in deed book 1111 page 55 of the said county records and being further described as follows.

Beginning for reference at an iron pipe at the Southwest corner of the Southeast quarter of section 2. Thence along the section line North 89 degrees 03 minutes 17 seconds East 932.46 feet to a railroad spike set in Bagley Road, passing an iron pipe found at 140.13 feet, said spike being the place of beginning for the tract herein described. Thence leaving said Bagley Road and with a new line North 00 degrees 48 minutes 31 seconds West 763.36 feet to an iron pin set. Thence North 89 degrees 03 minutes 17 seconds East 342.38 feet to an iron pin set in the East line of the grantors property. Thence along the said East line South 00 degrees 48 minutes 31 seconds East 763.36 feet to an iron pin set on the South line of section 2. Thence along the said South line South 89 degrees 03 minutes 17 seconds West 342.38 feet to the place of beginning, passing an iron pipe found at 189.43 feet, containing 6.00 acres more or less. Subject to all right of ways and easements either written or implied. All iron pins set are 5/8 inch by 30 inch rebar with I.D. caps stamped Walton S-7675. Bearings based on a previous survey by R.L. 

