

DESCRIPTION OF SURVEY FOR RANDY CAVINEE

JOB#809-2

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southwest Quarter, of Section #1, Township #17, Range #15, of the Congress Lands East of the Scioto River, being part of the F. G. Montgomery property described in deed reference Deed Book Volume 1064, Page 63 of said county's deed records, known as Muskingum County Auditor's Parcel Number 47-04-01-29-000, and more particularly described as follows;

Commencing at a stone (found) at the Southwest corner of Section #1, also being the common corner for Sections #2, #11, & #12 of said Township and Range; thence S 90 00 00 E 440.00 feet along the common line for Sections #1 and #12 to the Southeast corner of the Robert & Hazel Jones property described in deed reference Deed Book Volume 565, Page 524, being the place of beginning for the property herein intended to be described, passing the center of Slack Road (Township Road #90) at 286.97 feet and an iron (found) at 308.68 feet;

- #1- thence N 00 04 50 W 172.02 feet along the common line for said Jones and Montgomery properties to the center of Slack Road being a corner for the P & L Slack property described in deed reference Deed Book Volume 520, Page 1161, passing iron pins (set) at 5.00 feet and 152.44 feet;
- #2- thence N 49 54 20 E 384.88 feet along the center of said road and through said Montgomery property to an unmarked point;
- #3- thence S 00 00 00 E 419.91 feet continuing through said Montgomery property and leaving said road to an iron pin (set) on the South line of Section #1, passing an iron pin (set) at 19.61 feet;
- #4- thence N 90 00 00 W 294.19 feet along the common line for Sections #1 & #12 to the place of beginning containing 2.00 acres.

The bearings within the description are based on the South line of Section #1 being East as described in deed references of the area. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).




