

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southwest Quarter, of Section #1, Township #17, Range #15, of the Congress Lands East of the Scioto River, being part of the Galloway Land Company property recorded in Official Record Volume 2011, Pages 485, 502, & 519 of said county's deed records, further being part of Muskingum County Auditor's Parcel Number 47-04-01-29-004, and more particularly described as follows:

- Beginning at a stone (found) marked at the Northwest corner of said Southwest Quarter of Section #1, also being the common corner for the Northwest Quarter of said Section #1 and for the Northeast and Southeast Quarters of Section #2 of said Township and Range;
- #1- **THENCE South 84 degrees 03 minutes 00 seconds East 275.21 feet** along the common line for said Southwest and Northwest Quarters of Section #1 to an iron pin (found) on the West Bank of Kents Run, being a corner of the Mitchell Hoover ET AL property recorded in Official Record Volume 1780, Page 521;
- #2- **THENCE South 39 degrees 52 minutes 35 seconds East 540.71 feet** into said Southeast Quarter and along a common line for said Galloway and Mitchell properties and West Bank to an iron pin (found) at a common corner for said Galloway and Mitchell properties and for the CountryTyme Grove City, Ltd. property recorded in Official Record Volume 1986, Page 621 and Volume 2015, Page 671;
- #3- **THENCE South 18 degrees 39 minutes 30 seconds West 809.53 feet** leaving said West Bank and along said Galloway and CountryTyme properties to an iron pin (found);
- #4- **THENCE South 03 degrees 08 minutes 30 seconds West 391.10 feet** continuing along said Galloway and CountryTyme properties to an iron pin (found);
- #5- **THENCE South 12 degrees 32 minutes 00 seconds East 411.90 feet** continuing along said Galloway and CountryTyme properties to an iron pin (found);
- #6- **THENCE South 23 degrees 49 minutes 55 seconds East 603.29 feet** continuing along said Galloway and CountryTyme properties to an unmarked point in the centerline of Slack Road (Township Road #90), passing an iron pin (found) at 573.29 feet;
- #7- **THENCE along a curve to the left having, a chord bearing South 59 degrees 00 minutes 00 seconds West 25.20 feet**, a radius of 2173.89 feet, and arc length of 25.20 feet for said road to an unmarked point;
- #8- **THENCE North 23 degrees 49 minutes 55 seconds West 606.88 feet** leaving said road and through said Galloway property to an iron pin (set), passing an iron pin (set) at 30.00 feet;
- #9- **THENCE North 87 degrees 47 minutes 50 seconds West 76.69 feet** continuing through said Galloway property to a wood post found at a common corner for said Galloway property and for the Charles Printz property recorded in Deed Book Volume 1070, Page 183;
- #10- **THENCE North 87 degrees 47 minutes 50 seconds West 439.37 feet** continuing through said Galloway property to an iron pin (found) at a common corner for said Galloway and Printz properties on the common line for said Sections #1 & #2;
- #11- **THENCE North 03 degrees 08 minutes 30 seconds East 1995.94 feet** along said Section line to the place of beginning, passing an iron pin (found) at 883.29, **containing 22.56 acres.**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).




