BEING A PART OF THE SOUTHWEST QUARTER OF SECTION 2, THE NORTHEAST QUARTER OF SECTION 10 AND THE NORTHWEST QUARTER OF SECTION 11, TOWNSHIP 15, RANGE 14, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, NEWTON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SECTION 11;

THENCE NORTH 89 DEGREES 52 MINUTES 45 SECONDS EAST 197.41 FEET, ALONG THE NORTH LINE OF SECTION 11, TO A POINT IN THE CENTERLINE OF THE ZANESVILLE AND MAYSVILLE TURNPIKE AS LOCATED IN MAY 1930, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE SAID CENTERLINE, NORTH 40 DEGREES 33 MINUTES 23 SECONDS EAST 105.06 FEET (RECORD NORTH 40 DEGREES 30 MINUTES 00 SECONDS EAST 105.68 FEET) TO A POINT AT THE MOST NORTHERLY CORNER OF A TRACT OF LAND CONTAINING 0.25 MORE OR LESS ACRES, CONVEYED TO PAUL L. AND JEWEL B. SHAW (DEED BOOK 548, PAGE 482);

THENCE WITH THE NORTHERLY LINE OF SAID SHAW TRACT, SOUTH 60 DEGREES 17 MINUTES 37 SECONDS EAST 107.08 FEET (RECORD SOUTH 60 DEGREES 18 MINUTES 00 SECONDS EAST 107.09 FEET) TO AN EXISTING IRON PIN (AXLE) ON THE EASTERLY RIGHT-OF-WAY OF STATE ROUTE 22 (NEW LOCATION), SAID POINT BEING NORTH 40 DEGREES 33 MINUTES 23 SECONDS EAST 34.84 FEET FROM AN EXISTING CONCRETE MONUMENT AT 75 FEET RIGHT OF STATION 391+72.17;

THENCE CONTINUING SOUTH 60 DEGREES 17 MINUTES 37 SECONDS EAST ALONG THE SAID NORTHERLY LINE, PASSING THE SOUTH LINE OF SECTION 2 AT 53.12 FEET, A TOTAL DISTANCE OF 279.49 FEET TO AN IRON PIN SET;

THENCE LEAVING THE SAID NORTHERLY LINE AND TRAVERSING THROUGH THE 48.819 MORE OR LESS ACRE TRACT CONVEYED TO CHARMA CAMPBELL (DEED BOOK 1013, PAGE 79) THE NEXT TWO COURSES AND DISTANCES:

- 1) SOUTH 40 DEGREES 33 MINUTES 23 SECONDS WEST 655.72 FEET TO AN IRON PIN SET;
- 2) NORTH 87 DEGREES 17 MINUTES 58 SECONDS WEST 480.85 FEET TO A POINT IN THE ABOVE SAID CENTERLINE OF THE ZANESVILLE AND MAYSVILLE TURNPIKE, PASSING AN IRON PIN SET AT 373.20 FEET;

THENCE WITH THE SAID CENTERLINE, NORTH 40 DEGREES 33 MINUTES 23 SECONDS EAST 772.98 FEET TO THE PLACE OF BEGINNING.



