Situated in Newton Township, Muskingum County, Ohio. Being lot 84 and 40 feet off the Western side of lot 85 of Broadvue Acres Subdivision Re-Plat (P.B. 11, Pg. 34) and being described as follows:

Beginning at a set rebar in the Southwest corner of lot 83 of Broadvue Acres Subdivision Re-Plat (P.B. 11, Pg. 34);

Thence, **N.45°31'54"E.** a distance of **128.41 feet** along the South side of lot 83 to a set rebar;

Thence, **S.43°26'57"E.** a distance of **279.07 feet** through said lot and along the lands, now or formerly, owned by S. Jenkins (1000/271) to a found iron pin;


Thence, **S.46°59'09"W.** a distance of **130.73 feet** along the South lines of lot 85 and 84 to a found iron pin on the Southwest corner of lot 84;

Thence, **N.42°57'51"W.** a distance of **275.80 feet** along the West line of lot 84 to the point of beginning.


