Situated in the State of Ohio, County of Muskingum, Township of Newton, being part of Sections 1 & 12, T15, R14 and being all of the lands now owned by Clyde D. Hina & Vicki Hina (OR 2424-503) and more particularly described as follows.

Beginning for reference at an iron pin found at the southwest corner of the northwest quarter of Section 12, thence N02°54'53"E, a distance of 2502.49 feet to a point in the center of Jonathan Creek and the principal place of beginning.

Thence with the center of said Jonathan Creek the following four (4) courses:

1. N18°48'04"E, a distance of 192.83 feet to a point;
2. N25°36'04"E, a distance of 384.36 feet to a point;
3. N54°24'28"E, a distance of 88.18 feet to a point;
4. N65°44'14"E, a distance of 237.27 feet to point, also being the northwest corner of the lands now owned by Nicole R. Tipton (OR 1606-656);

thence leaving the center of said Jonathan Creek and going with the common line of said Hina/Tipton, S28°55'06"E, a distance of 599.02 feet to an iron pin found on said Tipton's southwest corner passing iron pins found at 69.02 feet and 267.46 feet;

thence with the easterly line of said Hina's lands, S41°12'45"W, a distance of 402.71 feet to an iron pin found on the easterly corner of the lands now owned by Betty J. Foraker & Michael L. Foraker (OR 2586-292);

thence with the common line of said Foraker/Hina the following three (3) courses:

1. N48°26'09"W, a distance of 416.97 feet to an iron pin found, passing iron pins found at 65.20 feet and 240.20 feet;
2. S27°39'25"W, a distance of 118.26 feet to an iron pin found;
3. S18°16'14"W, a distance of 156.47 feet to an iron pin found on the north line of the land now owned by Todd R. Bogner (OR 2776-249);


