Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, part of the Northwest Quarter of Section 8, bounded and described as follows:

Commencing at the Southwest corner of the Northwest Quarter of Section 8; thence South $89^{\circ} 41' 39''$ East on the South line of said section 2147.14 feet to an iron pin found; thence leaving quarter section line North $11^{\circ} 34' 00''$ West 157.52 feet to an iron pin found, the place of beginning; thence North $89^{\circ} 41' 39''$ West along Steve Milatovich, Vol. 960, Page 227, 1130.40 feet to an iron pin found; thence along the North line of Steve Milatovich, Vol. 891, Page 220, the next three (3) courses and distances, North $71^{\circ} 29' 16''$ West 238.96 feet to an iron pin, North $73^{\circ} 49' 36''$ West 171.38 feet to an iron pin and North $85^{\circ} 08' 36''$ West 421.54 feet to a point in Stine Road passing an iron pin at 394.54 feet; thence in Stine Road the following two (2) courses and distances, North $23^{\circ} 46' 55''$ West 75.06 feet to a point and North $24^{\circ} 40' 59''$ West 54.89 feet to a point; thence along the split line of Myra J. Hartman, Vol. 968, Page 43, South $89^{\circ} 41' 39''$ East 2010.14 feet to an iron pin set, passing an iron pin set at 30.00 feet; thence South $3^{\circ} 12' 10''$ West along Ralph Lee, Vol. 550, Page 422, 273.63 feet to the place of beginning, containing 10.40 acres more or less.

Bearings are based on the South line of the Northwest Quarter of Section 8 bearing South $89^{\circ} 41' 39''$ East.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.


