Situated in the State of Ohio, in the County of Muskingum, and in the Township of Newton, and bounded and described as follows:

Being in the Northwest corner of Section 11 and Northeast corner of Section 10, Township 15, Range 14, and more particularly described as follows:

Beginning for a description at the Northwest corner of said Section 11 (an existing iron pin bears South 00 degrees 47 minutes East 0.36 feet); thence run South 89 degrees 52 minutes East along the north line of Section 11 a distance of 134.08 feet to an iron pin (rebar) set on the northwesterly right-of-way line of Maysville Pike (State Route 22), an existing concrete monument bears North 40 degrees 48 minutes East therefrom a distance of 5.48 feet; thence run South 40 degrees 48 minutes West along said right-of-way line a distance of 147.82 feet to an iron pin (rebar) set on the northerly line of the lands conveyed to Paul L. Corbett and Lillian A. Corbett as recorded in Deed Book 508, Page 87, of the Public Records of said County; thence along the line of said Corbett lands North 61 degrees 45 minutes West a distance of 231.85 feet to an iron pin (axle) found on the north line of said Section 10; thence run North 89 degrees 09 minutes East along the Section Line a distance of 166.76 feet to the Place of Beginning containing 0.388 Acre, more or less.


0.177 Acre thereof lies in Section 10 and being Parcel No. 47-47-27-01-36-000.
