Situated in the State of Ohio, County of Muskingum,
Township of Newton, T 15, R 14, Northeast Quarter of
Section 10 and Northwest Quarter of Section 11 bounded
and described as follows:

Parcel One 47-27-04-02 3150 MAYSVILLE Pike

Being part of Lot No. Seven of Wiley's Subdivision, Plat Book 5, Page 87 and also part of the Northeast Quarter of Section 10; beginning at an iron pin at the Northeast corner of Lot No. 7 of Wiley's Subdivision; thence South $0^{\circ} 12'$ East 603.71 feet to an iron pin; thence South $74^{\circ} 12''$ West 94.38 feet to an iron pin; thence North $79^{\circ} 08'$ West 205.69 feet to an iron pin; thence North $39^{\circ} 03'$ West 313.82 feet to a concrete monument on U. S. Route 22 East right of way; thence along said right of way the following three courses and distances North $39^{\circ} 19' 42''$ East 51.60 feet, North $11^{\circ} 49' 23''$ East 75.99 feet and North $39^{\circ} 19' 42''$ East 315.21 feet; thence leaving Route 22 right of way South $87^{\circ} 20'$ East 240.67 feet to the place of beginning passing a concrete monument at 18.97 feet containing 5.40 acres more or less.

Parcel Two 47-30-02-09

Being part of the Northwest Quarter of Section 11 bounded and described as follows: Beginning at the Northeast corner of Lot No. 7 of Wiley's Subdivision on the West line of the Northwest Quarter of Section 11; thence South $87^{\circ} 20'$ East 152.16 feet to an iron pin; thence South $2^{\circ} 39' 07''$ East 977.79 feet to a corner post; thence North $89^{\circ} 22' 24''$ West 193.85 feet to a four (4) inch steel pipe corner on section line; thence along the West line of Section 11 North $0^{\circ} 12'$ West 981.71 feet to the place of beginning containing 3.89 acres more or less.


