BEING A PART NORTHWEST QUARTER OF SECTION 14, TOWNSHIP 17, RANGE 15, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, NEWTON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (1/2 INCH ROD) AT THE NORTHEAST CORNER OF SAID NORTHWEST QUARTER OF SECTION 14;

THENCE SOUTH 00 DEGREES 06 MINUTES 46 SECONDS WEST 2639.32 FEET ALONG THE EAST LINE OF SECTION 14 TO AN EXISTING IRON PIN (5/8 INCH REBAR), SAID IRON PIN SET BEING THE SOUTHEAST CORNER OF SAID NORTHWEST CORNER SECTION 14, ALSO SAID IRON PIN SET BEING THE CORNER OF A TRACT CONVEYED TO T. RUSNAK AS RECORDED IN VOLUME 687, PAGER 78 OF THE MUSKINGUM COUNTY DEED RECORDS;

THENCE NORTH 89 DEGREES 33 MINUTES 05 SECONDS WEST 1418.19 FEET, ALONG THE SOUTH LINE OF THE SAID NORTHWEST QUARTER, TO AN EXISTING IRON PIN (5/8 INCH REBAR), SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 1038.49 FEET;

THENCE CONTINUING WITH THE SAID SOUTH LINE, NORTH 89 DEGREES 33 MINUTES 05 SECONDS WEST 1145.52 FEET TO AN IRON PIN SET;

THENCE WITH THE WEST LINE OF THE SAID NORTHWEST QUARTER (THE WEST LINE OF MUSKINGUM COUNTY), NORTH 00 DEGREES 01 MINUTES 59 SECONDS EAST 722.55 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR), SAID IRON PIN BEING SOUTH 00 DEGREES 01 MINUTES 59 SECONDS EAST 1916.37 FEET FROM AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE LEAVING THE SAID WEST LINE AND WITH THE SOUTH AND EAST LINES OF A TRACT CONVEYED TO W. AND C. JAMES (DEED VOLUME 1102, PAGE 120) THE NEXT 3 COURSES AND DISTANCES:

1. SOUTH 89 DEGREES 56 MINUTES 13 SECONDS EAST 245.38 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);
2. NORTH 00 DEGREES 11 MINUTES 14 SECONDS WEST 578.82 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);
3. NORTH 11 DEGREES 50 MINUTES 55 SECONDS EAST 588.37 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE SOUTH LINE OF A TRACT CONVEYED TO M. WERNER (DEED VOLUME 1110, PAGE 648), SOUTH 89 DEGREES 06 MINUTES 17 SECONDS EAST 814.68 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE WEST LINE OF A TRACT CONVEYED TO M. AND L. TAGGERT (DEED VOLUME 1176, PAGE 515), SOUTH 10 DEGREES 41 MINUTES 41 SECONDS WEST 480.36 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE SOUTH LINE OF THE SAID TAGGERT TRACT, SOUTH 83 DEGREES 10 MINUTES 30 SECONDS EAST 530.75 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

COMMENCING AT AN EXISTING IRON PIN (1/2 INCH ROD) AT THE NORTHEAST CORNER OF SAID NORTHWEST QUARTER OF SECTION 14;

THENCE SOUTH 00 DEGREES 06 MINUTES 46 SECONDS WEST 1459.93 FEET ALONG THE EAST LINE OF SECTION 14 TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THIS EASEMENT;

THENCE LEAVING THE SAID EAST LINE AND TRAVERSING THROUGH THE 17.251 ACRE TRACT CONVEYED TO G. AND C. RUSNAK (VOLUME 1153, PAGE 654) WITH THE CENTER OF A 20 FOOT WIDE INGRESS AND EGRESS EASEMENT THE FOLLOWING 8 COURSES AND DISTANCES:




