Tract One, Parcel One

Situated in the State of Ohio, County of Muskingum, Township of Newton, bounded and described as follows:

Being a part of Section 15, Township 15, Range 14, Congress Lands East of the Scioto River, and more particularly described as follows:

Beginning at a stone found on the Northeast corner of the Northeast Quarter of said Section 16,

thence along the line common to Sections 15 and 16, South 02 degrees 53 minutes 57 seconds West 1327.57 feet to an iron pin found on the southeast corner of lands now owned by Kenneth F. Hamler (OR 2349-112) and on the north line of the right of way of the former Connecting Railway operated by the Pennsylvania Railroad;

thence along said right of way and along the lands now owned by Muskingum County as the Avondale Home for Children (DR 152-289) the following two courses:

- 1) South 01 degrees 47 minutes 07 seconds West 25.26 feet to a point;
- 2) South 87 degrees 08 minutes 00 seconds East 101.80 feet to the principal place of beginning, passing an iron pin set at 96.80 feet;

thence along the south line of said Muskingum County lands South 86 degrees 54 minutes 18 seconds East 906.24 feet to a stone found;

thence along the west line of lands now owned by Gary S. Dalzell (DR 1143-425) South 00 degrees 39 minutes 55 seconds East 87.97 feet to an iron pin found;

thence along the west line of lands now owned by Lawrence W. Reed (OR 2079-855) and Robert D. Hale (OR 1762-50) South 03 degrees 31 minutes 34 seconds West 172.45 feet to a 3/4 inch iron pipe found;

thence along the west line of lands now owned by Jill Beckert (OR 2241-599) South 03 degrees 40 minutes 44 seconds West 257.81 feet to an iron pin found;

thence along the west line of lands now owned by Thomas R. Hitchcock, Jr. (DR 1132-352) South 03 degrees 01 minutes 52 seconds West 162.86 feet to a steel post on the north line of said right of way of the former Connecting Railway;

thence along said north right of way line the following two courses:

- 1) North 44 degrees 02 minutes 07 seconds West 605.51 feet to an iron pin set;
- 2) with a curve to the left having a radius of 1211.28 feet, an arc length of 541.21 feet, a chord bearing of North 56 degrees 50 minutes 08 seconds West, and a chord length of 536.72 feet to the principal place of beginning, containing 6.045 acres, more or less.

thence along the line common to Sections 15 and 16, South 02 degrees 53 minutes 57 seconds West 1327.57 feet to an iron pin found on the southeast corner of lands now owned by Kenneth F. Hamler (OR 2349-112) and on the north line of the right of way of the former Connecting Railway operated by the Pennsylvania Railroad;

thence crossing said right of way South 03 degrees 13 minutes 14 seconds West 83.35 feet to an iron pin found on the northeast corner of lands now owned by Kenneth F. Hamler and Janice L. Hamler-Moody (OR 2353-800);

thence along the east line of said Hamler and Hamler-Moody South 02 degrees 54 minutes 13 seconds West 20.94 feet to an iron pin set on the south right of way line of said former Connecting Railway and the principal place of beginning;

thence along said south right of way line the following three courses:

- 1) South 69 degrees 49 minutes 58 seconds East 62.58 feet to an iron pin set;
- 2) with a curve to the right having a radius of 1081.28 feet, an arc length of 410.46 feet, a chord bearing of South 58 degrees 57 minutes 15 seconds East, and a chord length of 408.00 feet to an iron pin set;
- 3) South 48 degrees 04 minutes 46 seconds East 757.12 feet to an iron pin set;

thence along the west line of said right of way line and the west line of lands now owned by Pamela Kennedy (OR 2364-415) South 01 degrees 48 minutes 58 seconds West 574.61 feet to the center of Crock Road (Twp. Rd. 265), passing a railroad tie fence post at 204.40 feet and an iron pin set at 554.61 feet;

thence along the north line of lands now owned by Robert B. Marlow, Jr. (OR 1753-81), James E. and Trudy Reed (DR 1132-345) and Sandra K. Riley (OR 2449-184) North 86 degrees 21 minutes 01 seconds West 1018.62 feet to a one inch iron pin found on the northeast corner of lands now owned by Steve Gebhart (OR 2588-777);

thence through the lands of said Ohio Franklin Realty, LLC (OR 2568-853) and along the line common to Sections 15 and 16 North 02 degrees 53 minutes 38 seconds East 825.53 feet to an iron pin found on the southeast corner of said Hamler and Hamler-Moody lands;

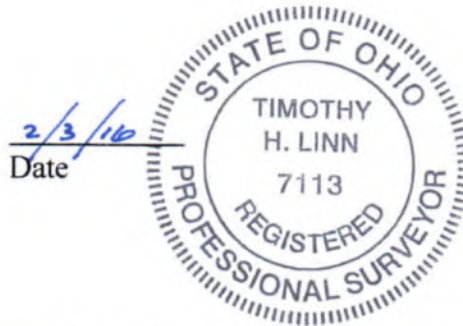

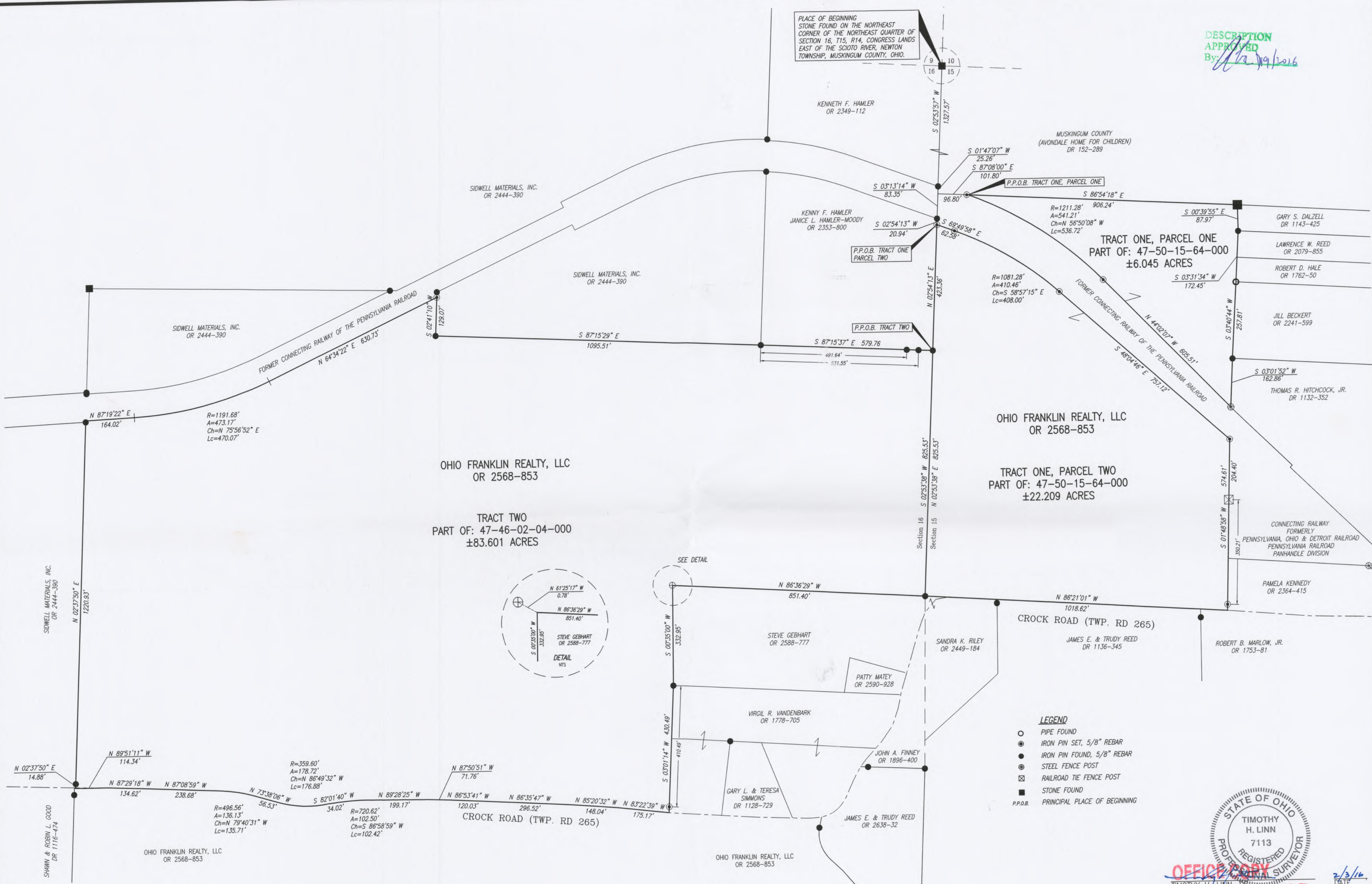

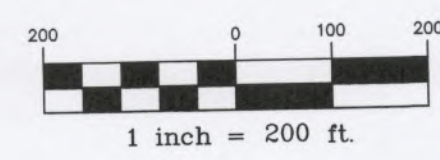
