Section 15; Thence North $89^{\circ}35'07''$ East 327.24 feet to a point; Thence South
 $00^{\circ}24'53''$ East 50.00 feet to a point; Thence South $44^{\circ}54'53''$ West 56.24 feet to a
point; Thence South $00^{\circ}14'39''$ West 70.46 feet along Ro-dayle Drive to an iron pin the
place of beginning; Thence South $89^{\circ}45'21''$ East 120.24 feet to an iron pin; Thence
South $00^{\circ}47'25''$ West 111.60 feet to an iron pin; Thence North $89^{\circ}45'21''$ West 120.78
feet to an iron pin; Thence along Ro-dayle Drive the next 2 courses and distances on a 90
foot radius to the left the chord of which bears North $5^{\circ}35'23''$ East along Ro-dayle Drive
17.17 feet to a point, and along Ro-dayle Drive North $00^{\circ}14'39''$ East 94.50 feet to the
place of beginning containing 0.307 acres more or less.

Bearings are based on the North line of the Northeast Quarter of Section 15 bearing North
 $89^{\circ}35'07''$ East.

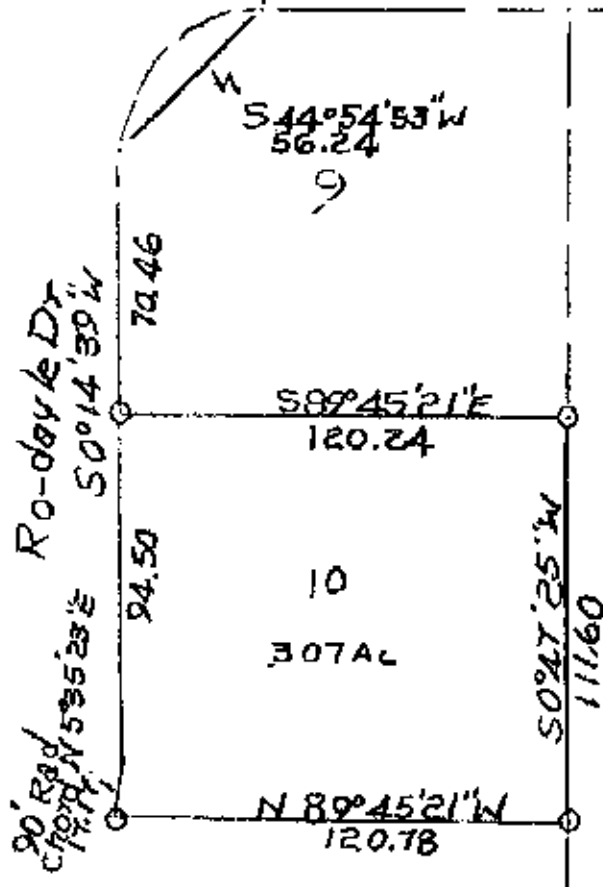
