**LEGAL DESCRIPTION FOR

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF NEWTON, AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 13, TOWNSHIP 15, RANGE 14, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1131, PAGE 134; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 13, THENCE, NORTH 05 DEGREES - 00 MINUTES - 00 SECONDS EAST, 1313.18 FEET TO AN IRON PIN FOUND, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 85 DEGREES - 18 MINUTES - 00 SECONDS WEST, 273.29 FEET TO AN IRON PIN FOUND IN THE CENTER OF TIPTON ROAD; THENCE, NORTH 55 DEGREES - 37 MINUTES - 09 SECONDS WEST, 465.00 FEET TO AN IRON PIN FOUND AT THE INTERSECTION OF EAST DARLINGTON ROAD (TOWNSHIP ROAD 74); THENCE, ALONG THE CENTERLINE THEREOF, THE FOLLOWING SEVEN (7) COURSES AND DISTANCES:

- 1) NORTH 26 DEGREES - 31 MINUTES - 06 SECONDS EAST, 217.66 FEET TO A POINT;
- 2) NORTH 43 DEGREES - 16 MINUTES - 49 SECONDS EAST, 50.71 FEET TO A POINT;
- 3) NORTH 65 DEGREES - 21 MINUTES - 24 SECONDS EAST, 47.67 FEET TO A POINT;
- 4) NORTH 73 DEGREES - 35 MINUTES - 58 SECONDS EAST, 157.38 FEET TO A POINT;
- 5) NORTH 70 DEGREES - 11 MINUTES - 44 SECONDS EAST, 264.85 FEET TO A POINT;
- 6) NORTH 57 DEGREES - 45 MINUTES - 50 SECONDS EAST, 95.25 FEET TO A POINT;
- 7) NORTH 42 DEGREES - 53 MINUTES - 41 SECONDS EAST, 96.24 FEET TO A POINT;


