

Arvilla Mahon etal

Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, Section 13, bounded and described as follows:

Being part of Arvilla Mahan Vol. 626, Page 25, Parcel No. 47-52-13-09-000.

Commencing at a stone found at the Southeast Corner of Northwest Quarter of Section 13; Thence North $84^{\circ}57'40''$ West 1413.96 feet to an iron pin; Thence North $5^{\circ}16'03''$ East 490.96 feet to an iron pin set the place of beginning; Thence North $5^{\circ}16'03''$ East 122.30 feet to an iron pin found; Thence along the 3.82 acre Parcel the next two courses and distances: North $64^{\circ}37'21''$ East 423.03 feet to an iron pin found, North $51^{\circ}31'28''$ East 238.94 feet to an iron pin found,

Thence along the new split line of Arvilla Mahon Vol. 626, Page 25 and part of 36.09 acres the next four courses and distances: South $19^{\circ}21'49''$ West 64.90 feet to an iron pin set, South $50^{\circ}27'23''$ West 167.75 feet to an iron pin set, South $16^{\circ}15'27''$ West 242.90 feet to an iron pin set and South $82^{\circ}02'44''$ West 365.13 feet to an iron pin set the place of beginning containing 1.82 acres more or less:

Bearings are based on the West line of the Northwest Quarter of Section 13 bearing North $5^{\circ}15'30''$ West.

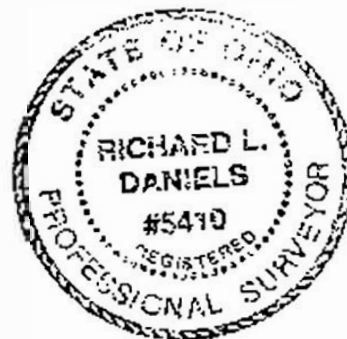

Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.

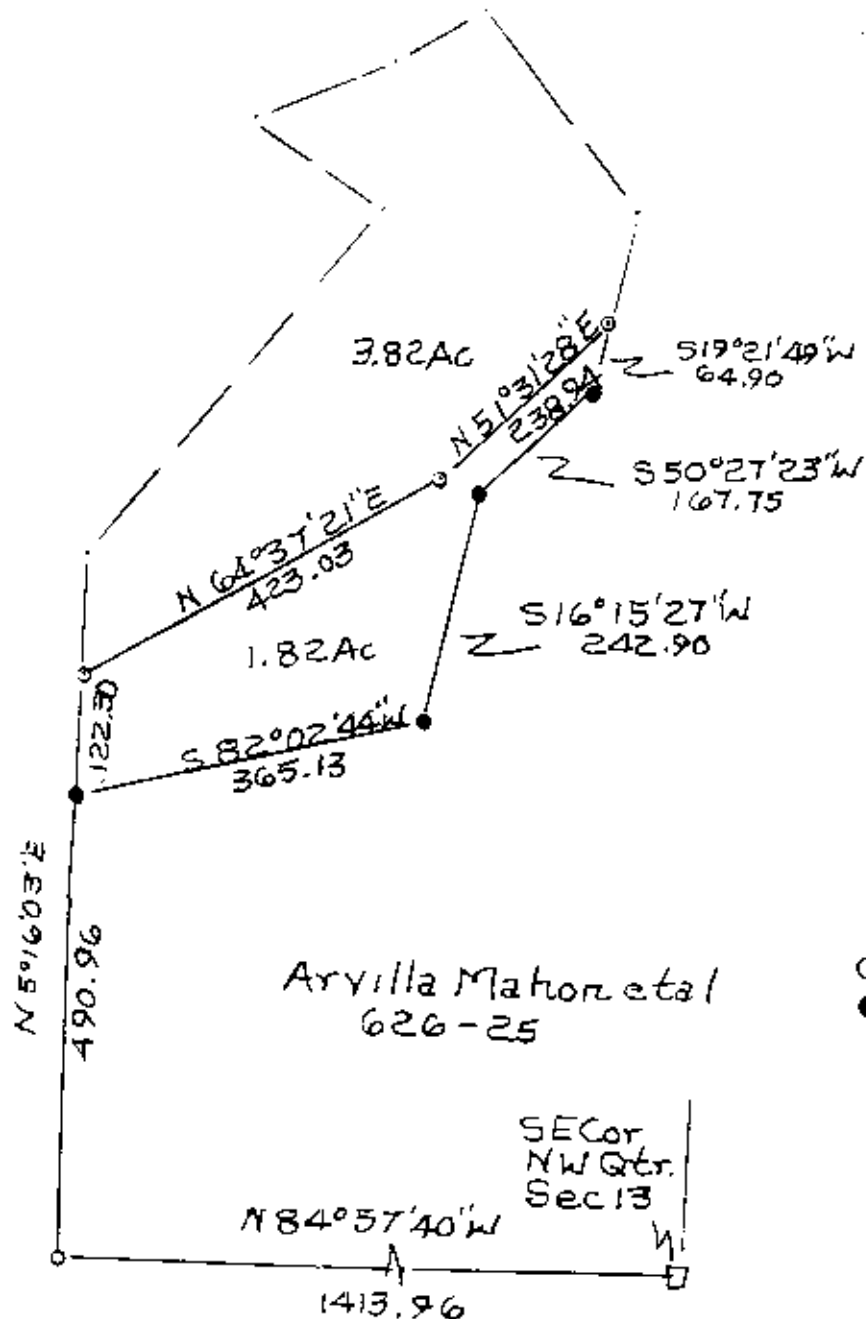

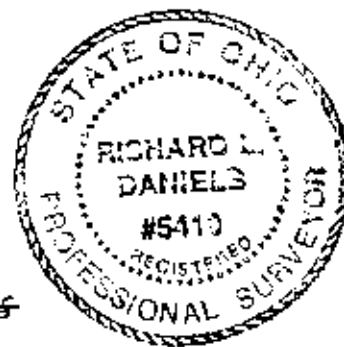
