PART OF AUDITORS PARCEL
47-52-13-10-000 (1.84 Acres)

Situated in the Northeast quarter of Section 13, T-15, R-14, Newton Township, Muskingum County, Ohio.

Commencing at a stone found marking the Southwest corner of the Northeast quarter of Section 13; thence, N.05°00'00"E. a distance of 498.68 feet along the West line of said quarter section to a point, being located S.05°00'00"W. a distance of 380.07 feet from a found iron pin on the South side of Tipton Road; thence; S.85°00'00"E. a distance of 484.80 feet through the lands of T. Fitz (1104/517) to a point in the center of Tipton Road, BEING THE POINT OF BEGINNING;

Thence, N.72°22'19"E. a distance of 282.91 feet through the lands of T. Fitz (1104/517) to a set rebar, passing a set rebar at 29.58';

Thence, N.72°12'21"E. a distance of 107.89 feet through said Fitz lands to a set rebar;

Thence, S.11°08'03"E. a distance of 270.87 feet through said Fitz lands to a set rebar;

Thence, S.87°31'17"W. a distance of 127.02 feet through said Fitz lands to a set rebar;

Thence, S.75°23'31"W. a distance of 187.00 feet through said Fitz lands to a point in the center of Tipton Road, passing a set rebar at 168.61';

Thence, N.16°32'56"W. a distance of 118.87 feet along the center of Tipton Road to a point;

Thence, N.33°19'50"W. a distance of 49.73 feet along the center of Tipton Road to a point;

Thence, N.51°28'19"W. a distance of 71.10 feet along the center of Tipton Road to the point of beginning.

The above described parcel contains 1.84 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.



SURVEY PLAT FOR TROY FITZ


