

EXHIBIT A

Being a tract of land in the Southeast Quarter of Section 24, Range 14W, Township 15N, Newton Township, Muskingum County, State of Ohio, and being further described as follows;

Note: North based on Deed 1086/295. All pins indicated as set are 3/4" x 30" rebars with aluminum cap.
Research Data: Deeds, plats and surveys as shown on plat and called out in this description.

Beginning at a point on the centerline of County Road 46, said point being located from a stone with an "x" recovered at the Northwest corner of the said Southeast Quarter by the following six (6) courses;

1. with the West line of the said Southeast Quarter, South 5 degrees 28' 11" West, a distance of six hundred seventy and no hundredths (670.00) feet to a recovered 3/4" rebar with aluminum cap;
2. continuing with the West line of the said Southeast Quarter and continuing South 5 degrees 28' 11" West, a distance of sixty-eight and fifty-seven hundredths (68.57) feet to a point on the said centerline of County Road 46;
3. with the said centerline of County Road 46, South 10 degrees 54' 15" East, a distance of seventy-three and no hundredths (73.00) feet to a point;
4. continuing with the said centerline of County Road 46, South 5 degrees 39' 03" East, a distance of ninety-five and forty-four hundredths (95.44) feet to a point;
5. continuing with the said centerline of County Road 46, South 3 degrees 46' 37" West, a distance of sixty-four and fourteen hundredths (64.14) feet to a point;
6. continuing with the said centerline of County Road 46, South 7 degrees 56' 25" West, a distance of three hundred eighty-four and thirty-six hundredths (384.36) feet to the said beginning point;

thence, with the lands of Jerry F. & Michelli Barstow (1086/295 & 1697/819) the following five (5) courses;

1. South 85 degrees 07' 55" East, a distance of twenty-six and fourteen hundredths (26.14) feet to a set steel pin;
2. continuing South 85 degrees 07' 55" East, a distance of one hundred fourteen and sixty-eight hundredths (114.68) feet to a set steel pin;
3. South 1 degree 11' 24" East, a distance of two hundred sixty-one and twenty-four hundredths (261.24) feet to a set steel pin;
4. South 88 degrees 08' 49" West, a distance of one hundred thirty-six and ninety-seven hundredths (136.97) feet to a set steel pin;
5. continuing South 88 degrees 08' 49" West, a distance of forty-four and six hundredths (44.06) feet to a point on the said centerline of County Road 46;

thence, with the said centerline of County Road 46 the following three (3) courses;

1. North 6 degrees 17' 03" East, a distance of forty-two and ninety-five hundredths (42.95) feet to a point;
2. North 7 degrees 16' 11" East, a distance of two hundred eight and seventy-seven hundredths (208.77) feet to a point;
3. North 7 degrees 56' 25" East, a distance of twenty-nine and forty-nine hundredths (29.49) feet to the point of beginning;
