- 1. South 7°00'00" West, a distance of 212.65 feet to a Capped Rebar Set, passing an axle found at 20.74 feet;
- 2. South 26°58'00" East, a distance of 48.11 feet to a Capped Rebar Set;
- 3. South 63°30'00" East, a distance of 51.45 feet to an axle found;
- 4. South 63°30'00" East, a distance of 59.62 feet to the Southeast corner of the subject parcel, found in the centerline of Old Town Road (66' Right of Way);

Thence coincident with the south line of the subject parcel and the centerline of said Old Town Road the following 2 courses:

- 2. Thence coincident with a woven wire fence found on the west line of the subject parcel and the East line of said Kirkbride North 6°23′47″ West, a distance of 323.94 feet, retuning the POINT OF BEGINNING, passing a Capped Rebar Set at 303.94 feet.
