

DESCRIPTION OF SURVEY FOR
UNIONTOWN BAPTIST CHURCH

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southwest Quarter, Section 24, Township 17, Range 15, of the Congress Lands East of the Scioto River, **being all of** the Uniontown Baptist Church property recorded in Deed Book Volume "I", Page 56, of said county's deed records, further being all of Muskingum County Auditor's Parcel Number **47-54-04-68-000**, and more particularly described as follows;

Commencing at the unmarked center of Section 24, being in the roadbed of Old Town Road (County Road #652);

TIE-1 THENCE South 03 degrees 04 minutes 20 seconds West 714.88 feet along the Southeast and Southwest Quarters of said Section to the centerline of Maysville Pike (US Route 22);

TIE-2 THENCE North 86 degrees 33 minutes 45 seconds West 592.04 feet along the centerline of said Maysville Pike to an unmarked point at a corner of the Uniontown Baptist Church recorded in Deed Book Volume 993, Page 146;

TIE-3 THENCE North 03 degrees 26 minutes 10 seconds East 103.48 feet along the East line of said Church property to a concrete monument (found) on the right of way for said Maysville Pike and place of beginning for the property herein intended to be described;

#1- THENCE North 04 degrees 19 minutes 25 seconds East 219.84 feet along the common line for said Church properties to an iron pin (set) on the south line of Lot 9 of Porter's Addition recorded in Deed Book Volume "D", Page 571 and Plat Book "A-O", Page 50;

#2- THENCE South 86 degrees 37 minutes 00 seconds East 198.00 feet along the south line of said Addition to an iron pin (set) at the common corner for the said Church property and Robert Razor and Tonya Razor property recorded in Official Record Volume 1784, Page 153, passing an iron pin (set) at 6.79 feet, being the Southeast corner of said Lot 9 and the West side of an alley, also passing an iron pin (set) at 23.29 feet, being the Southwest corner of Lot 8 and the East side of an alley;

#3- THENCE South 02 degree 54 minutes 20 seconds West 217.08 feet along said Church and Razor properties to an iron pin (set) on the right of way for said Maysville Pike;

#4- THENCE North 87 degrees 23 minutes 15 seconds West 203.44 feet along said Church property and right of way to the place of beginning, **containing 1.01 acres.**




