thence along the Muskingum County/Perry County line North 86 degrees 50 minutes 53 seconds West 943.65 feet to an iron pin found on the existing north right-of-way of Loop Road (Township Road 71A), also being the southeast corner of Mary Rose Lane (50' wide) (DR 3255-799);

- 5. On a curve to the left having a radius of 150.00 feet, a delta angle of 20 degrees 59 minutes 45 seconds, a chord bearing and distance of North 62 degrees 17 minutes 38 seconds West 54.66 feet to a point, being the southwest corner of Fletcher Road (Township Road 802);

thence leaving the right-of-way of Mary Rose Lane (50' wide) (DR 3255-799) and along the west line of Fletcher Road (Township Road 802) the following eleven courses:

- 2. North 19 degrees 08 minutes 37 seconds West 272.84 feet to a point;
- 3. North 16 degrees 32 minutes 13 seconds West 140.82 feet to a point;
- 4. North 12 degrees 48 minutes 45 seconds West 115.64 feet to a point;
- 5. On a curve to the right having a radius of 370.00 feet, a delta angle of 24 degrees 41 minutes 12 seconds, a chord bearing and distance of North 00 degrees 28 minutes 10 seconds West 158.19 feet to a point;
- 6. On a curve to the left having a radius of 230.00 feet, a delta angle of 26 degrees 15 minutes 23 seconds, a chord bearing and distance of North 01 degrees 15 minutes 16 seconds West 104.48 feet to a point;
- 7. North 14 degrees 22 minutes 57 seconds West 235.45 feet to a point;
- 8. On a curve to the right having a radius of 920.00 feet, a delta angle of 08 degrees 35 minutes 44 seconds, a chord bearing and distance of North 10 degrees 05 minutes 05 seconds West 137.89 feet to a point;
- 9. North 05 degrees 47 minutes 12 seconds West 530.85 feet to a point;

- 10. North 08 degrees 41 minutes 31 seconds West 720.33 feet to a point;
- 11. North 15 degrees 39 minutes 31 seconds West 108.18 feet to a point on the south line of Shelly Materials, Inc. (DR 2957-339);

thence along the south line of Shelly Materials, Inc. (DR 2957-339) North 50 degrees 06 minutes 45 seconds East 43.86 feet to a point on the east line of Fletcher Road (Township Road 802);

thence leaving the south line of Shelly Materials, Inc. (DR 2957-339) and along the east line of Fletcher Road (Township Road 802) the following twelve courses:

- 1. South 15 degrees 39 minutes 31 seconds East 128.61 feet to a point;
- 2. South 08 degrees 41 minutes 31 seconds East 723.78 feet to a point;
- 3. South 05 degrees 47 minutes 12 seconds East 531.86 feet to a point;
- 4. On a curve to the left having a radius of 880.00 feet, a delta angle of 08 degrees 35 minutes 45 seconds, a chord bearing and distance of South 10 degrees 05 minutes 05 seconds East 131.90 feet to a point;
- 5. South 14 degrees 22 minutes 57 seconds East 235.45 feet to a point;
- 6. On a curve to the right having a radius of 270.00 feet, a delta angle of 26 degrees 15 minutes 23 seconds, a chord bearing and distance of South 01 degrees 15 minutes 16 seconds East 122.65 feet to a point;
- 7. On a curve to the left having a radius of 330.00 feet, a delta angle of 24 degrees 41 minutes 07 seconds, a chord bearing and distance of South 00 degrees 28 minutes 10 seconds East 141.08 feet to a point;
- 8. South 12 degrees 48 minutes 45 seconds East 114.34 feet to a point;
- 9. South 16 degrees 32 minutes 13 seconds East 138.61 feet to a point;
- 10. South 19 degrees 08 minutes 37 seconds East 269.66 feet to a point;
- 11. South 22 degrees 56 minutes 48 seconds East 56.51 feet to a point;
- 12. South 36 degrees 16 minutes 28 seconds East 27.20 feet to the place of beginning containing 2.367 acres, more or less.


