Beginning at an iron pin set at the Southwest Corner of Lot 51; Thence North 03°58'42" East along a 20.00 foot alley and the West line of Lots 51 and 52 100.00 feet to a point the Northwest Corner of Lot 52 from which an iron pin found bears South 58°09'47" West 0.24 feet; Thence South 86°01'18" East along the North line of Lot 52, 120.00 feet to a point from which an iron pin found bears South 54°30'20" West 0.49 feet; Thence South 03°58'42" West along Main Street (Fultonrose Road) 100.00 feet to an iron pin set on the North line of Third Street; Thence North 86°01'18" West along Third Street 120.00 feet to the place of beginning containing 0.275 Acres more or less:

Bearings are based on Main Street bearing North 03°58'42" East.



