Volume 1115, page 579, to a point in Harlan Road (Township Road 89) passing an iron
pin at 199.88, 1163.79, and 1638.88 feet; Thence along the center of Harlan Road the next
four courses and distances South $86^{\circ}06'41''$ East 461.81 feet to a point, South $86^{\circ}10'58''$
East 188.62 feet to a point, South $85^{\circ}46'50''$ East 200.25 feet to a point, and South

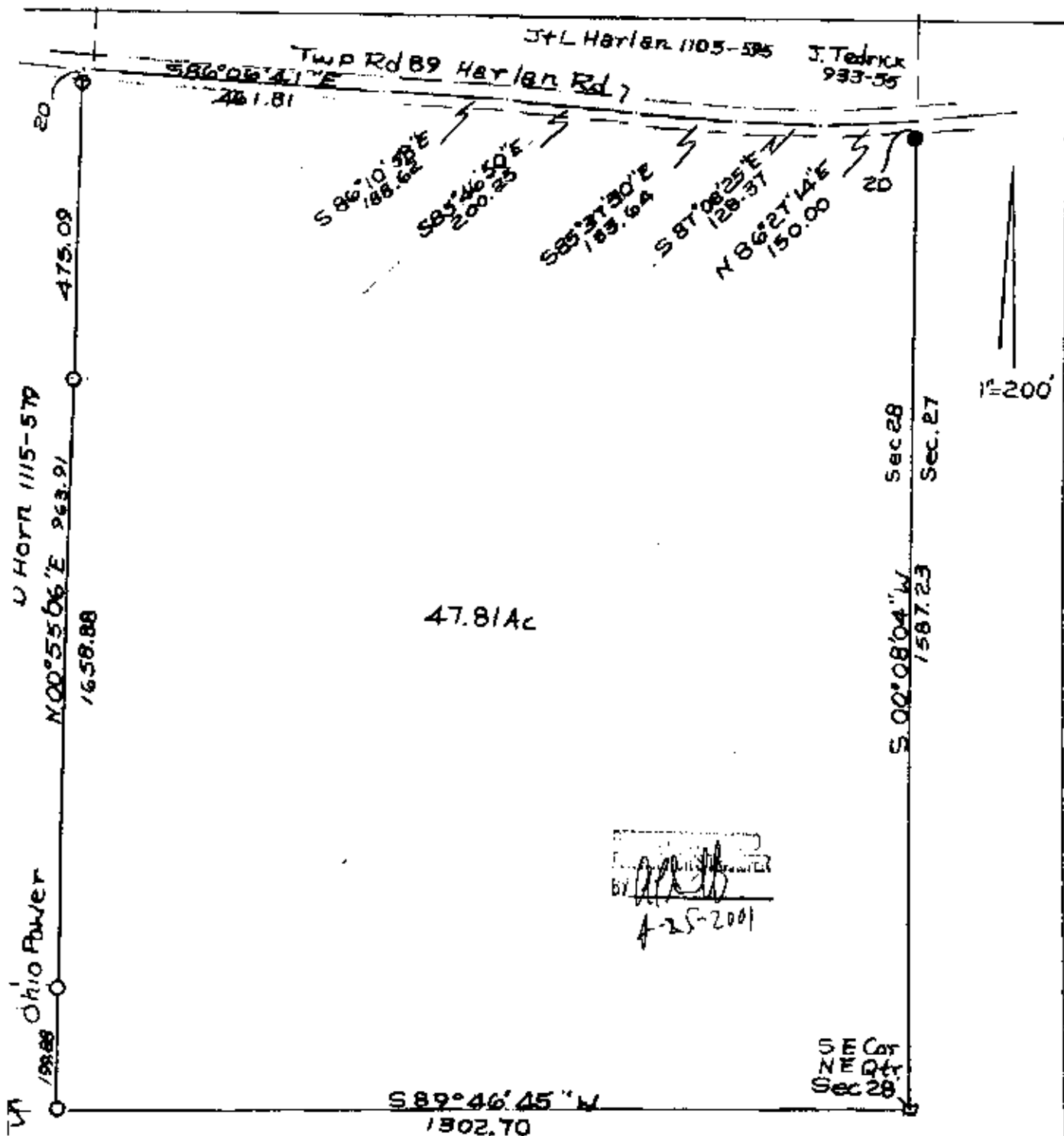
Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.
