ः ः च्युप्ताः Reginning at an iron pin found at the Southwest Corner of the Southeast Quarter of Section 33; thence along the Mid Section Line North 01 Degrees 13 Minutes 20 Seconds West 315.56 feet to an iron pin set; thence North 88 Degrees 43 Kinutes 16 Seconds East 505.22 feet to an iron pin found, passing an iron pin found at 255.25 feet; thence North 01 Degrees 37 Minutes 56 Seconds West 71.65 feet to an iron pin set; thence North 88 Degrees 44 Minutes 32 Seconds Bast 512.81 feet to an iron pin found, passing an iron pin found at 272.96 feet; thence South 73 Degrees 09 Minutes 28 Seconds East 255.34 feet to an iron pin set on the West R/W Line of St. Rt. 93; thence along said line South 14 Degrees 58 Minutes 31 Seconds West 106.86 feet to a concrete highway monument; thence along said line South 04 Degrees 24 Minutes 50 Seconds West 204.17 feet to an iron pin found; thence leaving said R/W along the South Line of Section 33 South 87 Degrees 42 Minutes 46 Seconds West 723.12 feet to an iron pin found; thence along said line South 90 Degrees 00 Minutes 00 Seconds West 487.53 feet to the place of beginning, containing 10.06 acres, more or less, subject to all legal highways and easemente.




