Perry OR Volume 1899, page 29, 220.50 feet to an iron pin set; Thence continuing along B.J. Perry North 62°09'26" West 506.32 feet to an iron pin set on the East right-of-way of Rosehill Road; Thence North 11°12'32" East along Rosehill Road 590.80 feet to an iron pin set; Thence leaving said road South 83°57'28" East along James Ransbottom Deed Volume 1091, page 523, 627.11 feet to the place of beginning containing 10.82 Acres more or less.


