Situated in the State of Ohio, Muskingum County, Newton Township, Township 15, Range 14, being part of the Southeast Quarter of Section 34. Being part of Theodore M. Graybill Volume 900, page 43, Parcel No. 47-92-01-06-000 . Bounded and described as follows:

Commencing at the Northeast corner of the Southeast Quarter of Section 34; Thence South 85° 44'09"West 1428.90 feet to an iron pin found at the Place of Beginning; Thence South 2° 47'37"East along Jerry May Volume 1123, page 10, 505.55 feet to a iron pin set; Thence through Theodore M. Graybill Volume 900, page 43 the next two courses and distances: North 81° 21'42"West 236.71 feet to a iron pin set, and South 55°32'16"West 366.71 feet to a point in center of Ransbottom Road, passing a iron pin set at 331.71 feet; Thence along center of Ransbottom Road the next nine courses and distances: North 14°01'45"East 66.51 feet to a point, North 16° 07'01"East 108.91 feet to a point, North 26°10'14"East 89.40 feet to a point, North 41°54'29"East 106.29 feet to a point, North 54°08'18"East 108.19 feet to a point, North 49°18'08"East 74.16 feet to a point, North 30°43'09"East 91.57 feet to a point, North 8°16'34"East 68.99 feet to a point, and North 3°40'11"East 78.72 feet to a point; Thence leaving Ransbottom Road North 85° 44'43"East 149.70 feet to the Place of Beginning, passing a iron pin at 55.16 feet. Containing 3.53 Acres more or less.


Iron pins set are No. 5 reinfotced bars 30 inches long with plastic I.D. caps ( R.L.S. 5410).




