Re-Survey of Wanda K. Suttles Lands in Newton Township, Muskingum County

Suttles (OR 2801-463), and being more particularly described as follows:

Beginning for reference at the Southeast Corner of the Northwest Quarter of Section 35, Township 15, Range 14, Congress Lands East of the Scioto River;

Thence, along the Quarter Section line, North 87 degrees 30 minutes 13 seconds West, 586.42 feet to an iron pin found on a north line of lands presently owned by Victoria I. May (OR 2454-944), and the Principal Place of Beginning:

Thence along said May lands the following three courses;

- 1.) North 13 degrees 01 minutes 51 seconds West, 214.14 feet to a two inch bolt found;
- 2.) North 66 degrees 56 minutes 39 seconds West, 455.57 feet to an iron pin found, (5/8 inch all thread), from which a half inch pipe bears South 44 degrees 36 minutes 48 seconds East 3.97 feet;
- 3.) North 04 degrees 09 minutes 49 seconds East, 393.51 feet to a point in the centerline of Payne Road (Twp. Rd. 262), passing a 2 inch bolt found at 369.34 feet;

Thence along said centerline following four courses;

- 1.) South 69 degrees 55 minutes 34 seconds East, 85.02 feet to point;
- 2.) South 72 degrees 01 minutes 11 seconds East, 226.74 feet to a point;
- 3.) South 73 degrees 39 minutes 33 seconds East, 99.74 feet to a point;
- 4.) South 76 degrees 28 minutes 36 seconds East, 90.74 feet to a point;

Thence along lands presently owned by Hina Heritage Preserve, LLC, (OR 2854-841, an undivided one half interest) and Payne Road Heritage Farm, LLC, (OR 2689-5, an undivided one half interest), **South 03 degrees 40 minutes 42 seconds West, 632.36 feet**, to the principal place of beginning, passing an iron pin found (one inch) at 21.49 feet, containing 4.81 acres, more or less, and being all of Auditor's Parcel Number 47-94-35-09-001, and 0.23 acres more or less in the assumed right of way of Payne Road (Twp.
