VOLUME 2214, PAGE 867 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS, NORTH 90 DEGREES 00 MINUTES 00 SECONDS WEST 2681.75 FEET TO A POINT IN THE CENTER OF MURPHY HILL ROAD (TOWNSHIP ROAD 82), PASSING EXISTING IRON PINS (5/8 INCH REBAR WITH CAP) AT 1411.49 FEET AND 2642.21 FEET;

THENCE WITH THE CENTERLINE OF THE SAID ROAD, ALSO BEING THE SOUTHERLY LINE OF THE SAID CHAD AND JACQUELYN NEWCOMER TRACT THE FOLLOWING FOUR COURSES AND DISTANCES:

3. WITH A CURVE TO THE LEFT HAVING A RADIUS OF 206.91 FEET (CHORD BEARING SOUTH 29 DEGREES 32 MINUTES 08 SECONDS EAST 141.34 FEET, DELTA ANGLE 39 DEGREES 56 MINUTES 34 SECONDS) AN ARC LENGTH OF 144.24 TO A POINT;
4. WITH A CURVE TO THE LEFT HAVING A RADIUS OF 206.91 FEET (CHORD BEARING SOUTH 53 DEGREES 31 MINUTES 18 SECONDS EAST 28.97 FEET, DELTA ANGLE 8 DEGREES 01 MINUTES 47 SECONDS) AN ARC LENGTH OF 29.00 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID CENTERLINE, AND THE SOUTHERLY LINE OF THE SAID CHAD AND JACQUELYN NEWCOMER TRACT THE FOLLOWING FIVE COURSES AND DISTANCES:
