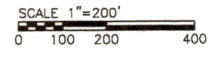
BEING ALL OF THE PARCEL CONVEYED TO MAXINE V. MONLUX IN O.R. VOLUME 2834, PAGE 97 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS, SITUATED IN THE SOUTHWEST QUARTER OF SECTION 2, TOWNSHIP 1, RANGE 6, OF THE UNITED STATES MILITARY LANDS, PERRY TOWNSHIP, MUSKINGUM COUNTY, OHIO.

BEARINGS ARE BASED ON OHIO STATE PLANE COORDINATE SYSTEM 1983(2011), OHIO SOUTH ZONE, GRID, DERIVED FROM A GPS OBSERVATION.

- NOTE 1: THE SOUTHWEST CORNER OF SECTION 2 BY PREVIOUS SUBDIVISION SURVEY (S.M. BOWMAN 2004) WAS NOT HELD AS THE SECTION CORNER FOR THIS SURVEY. EXISTING IRON PINS FROM PREVIOUS SURVEY OF LOSSY PARCEL, BY J.R. MARSHALL IN 1988 WERE USED TO ESTABLISH THE SECTION CORNER.
- NOTE 2: FOR DETAILS ON IRON PINS FOUND AND IRON PIN SET BETWEEN DANIEL MONLUX AND CURTIS MARLING SEE SURVEY FOR CURT MARLING AND DAN MONLUX (4 PARCELS) COMPLETED BY BASELINE SURVEYING ON MARCH 18, 2019.
- NOTE 3: SECTION LINE (SOUTH LINE OF SECTION 2) AND QUARTER SECTION LINE (EAST LINE OF THE SOUTHWEST QUARTER OF SECTION 2) AS ESTABLISHED BY PREVIOUS SURVEYS OF THE DANIEL MONLUX AND CURTIS MARLING PARCELS, COMPLETED BY R.L. DANIELS IN 1988, WERE NOT HELD FOR THIS SURVEY.
- NOTE 4: FLOOD ZONE A (NO BASE FLOOD ELEVATION) IS GRAPHICALLY PLOTTED FOR REFERENCE ONLY; THE EXACT LOCATION CAN ONLY BE DETERMINED BY AN ELEVATION CERTIFICATE.

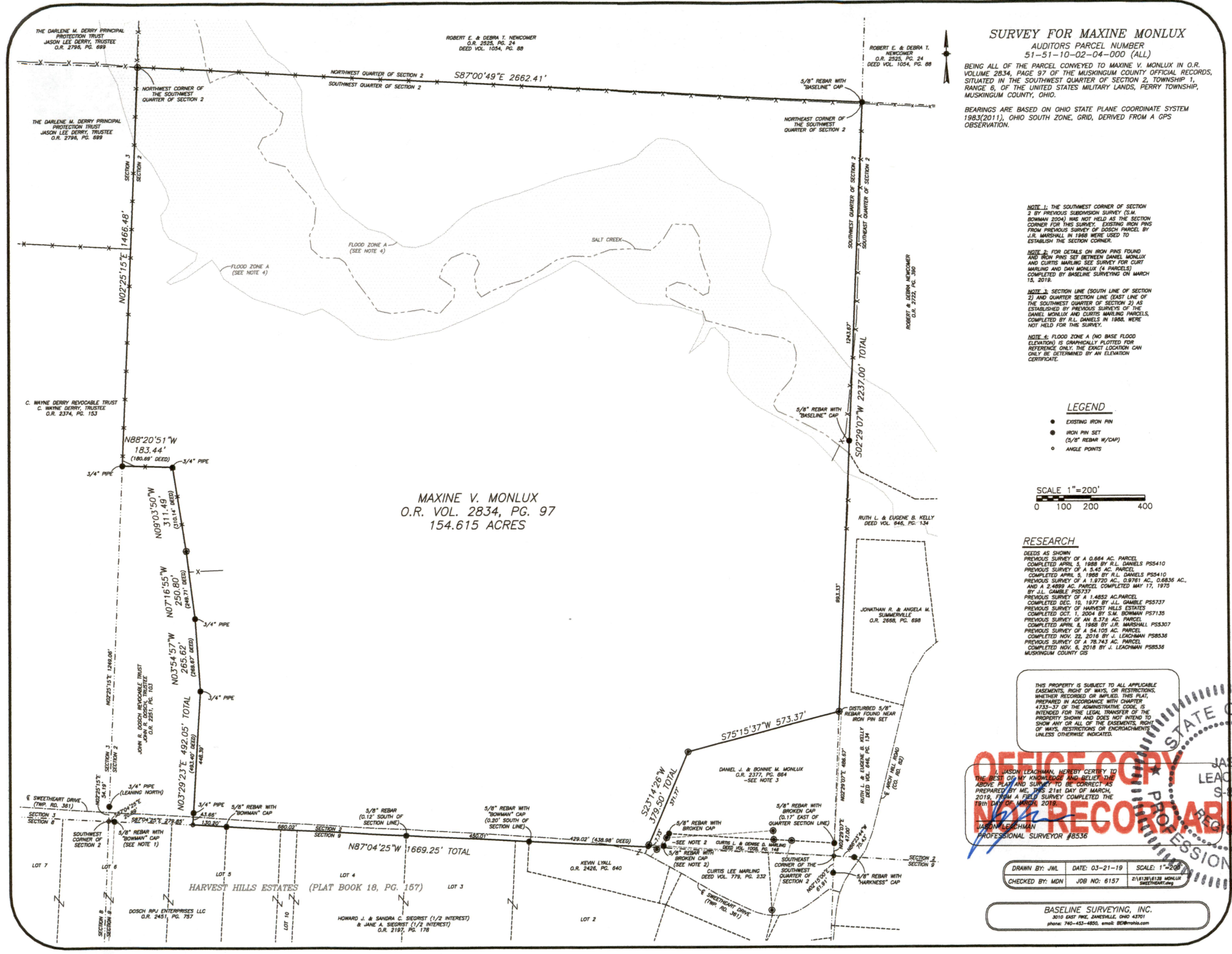
