

LARRY MOORE

Situated in the State of Ohio, Muskingum County, Perry Township. Being a part of the Southwest Quarter of Section Three, Township One, Range Six of the United States Military Lands more particulary described as follows:

Beginning at a stone at the Northwest corner of the southwest quarter of said section three, thence along said section line S 0°00'00" W, 649.00' to the center of Township Road Number 109 and the north line of D & B Warne as stated in Volume 548, Page 910 of the Muskingum County Deed Records, having passed through an iron pin (Ford axle) at 629.88'; thence along the centerline of said road and along the north line of the D & B Warne tract the next three courses: S 89°30'00" E, 275.00'; thence S 73°38'00" E, 1,094.00'; thence S 64°33'00" E, 111.80'; to the point of beginning of the parcel intended to be described, thence leaving said centerline N 18°45'39" E, 313.39' to an iron pin (set) having passed through an iron pin (set) at 29.30', thence S 82°24'21" E, 218.74' to an iron pin (set); thence S 23°33'55" W, 378.53' to a point in the centerline of said road having passed through an iron pin (set) at 348.97'; thence along said centerline N 64°33'00" W, 184.15' to the point of beginning containing 1.572 acres more or less.
