BEING A PART OF THE NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 1, RANGE 6, OF THE UNITED STATES MILITARY LANDS, PERRY TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (3/4 INCH REBAR) AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 8;

THENCE SOUTH 83 DEGREES 48 MINUTES 23 SECONDS EAST 1238.05 FEET TO AN EXISTING MONUMENT (AZ 18-101);

THENCE SOUTH 03 DEGREES 11 MINUTES 19 SECONDS EAST 1605.72 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 109 (HARVEST HILLS ROAD), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE CENTER OF SAID TOWNSHIP ROAD, SOUTH 05 DEGREES 41 MINUTES 02 SECONDS EAST 232.85 FEET TO A POINT;

THENCE LEAVING SAID TOWNSHIP ROAD AND TRAVERSING THROUGH A TRACT CONVEYED TO M. MARLING (VOLUME 1093, PAGE 68) THE FOLLOWING THREE COURSES AND DISTANCES;

- 1) SOUTH 88 DEGREES 59 MINUTES 28 SECONDS WEST 207.74 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 18.83 FEET;
- 2) NORTH 05 DEGREES 41 MINUTES 02 SECONDS WEST 232.85 FEET TO AN IRON PIN SET;
- 3) NORTH 88 DEGREES 59 MINUTES 28 SECONDS EAST, PASSING AN IRON PIN SET AT 182.95 FEET, A TOTAL DISTANCE OF 207.74 FEET TO THE PLACE OF BEGINNING.

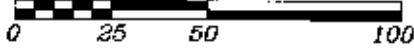
APPROXIMATE NORTH LINE SECTION 8
