LEGAL DESCRIPTION
TRACT 2

Situated in the State of Ohio, County of Muskingum, Township of Perry, and being part of Quarter Township 3, Township 1, Range 6; and being part of those lands intended to be described in Deed Volume 2117, page 239; being further bounded and described as follows:

Commencing at an iron pin found at the northeast corner of Lot "C" of Durbin Heights Number 2, Plat Book 15, page 47, thence, north 68 degrees – 02 minutes – 57 seconds east, 119.63 feet, along the south line of Shimoda Lane, to a point; thence, north 21 degrees – 57 minutes – 03 seconds west, 50.32 feet to an iron pin found on the north line of Shimoda Lane, and marking the southwest corner of those lands now or formerly owned by J. & J. Nolan (2229/436); thence, north 68 degrees – 03 minutes – 17 seconds east, 139.93 feet, along the southerly line thereof, to an iron pin found; thence, leaving the north line of said Shimoda Lane and along the easterly line of said Nolan property, north 17 degrees – 04 minutes – 13 seconds west, 386.03 feet to an iron pin found; and the *true point of beginning* for the parcel herein intended to be described;

Thence, north 89 degrees – 12 minutes – 47 seconds west, 99.18 feet, along the north line of said Nolan property, to an iron pin found;

Thence, south 86 degrees – 18 minutes – 01 seconds west, 45.15 feet to an iron pin found on the east line of a twenty (20) foot right-of-way and marking the northwest corner of said Nolan property;

Thence, along said right-of-way, north 04 degrees – 20 minutes – 50 seconds west, 25.75 feet to an iron pin found;

Thence, leaving said right-of-way and along the south line of those lands now or formerly owned by E.E., Jr. & P.A. Opdyke (521/12), the following three (3) courses and distances:

1. **north 86 degrees – 13 minutes – 58 seconds east, 43.00 feet** to an iron pin found;
2. **south 81 degrees – 01 minutes – 07 seconds east, 23.95 feet** to an iron pin found;
3. **south 89 degrees – 12 minutes – 47 seconds east, 72.80 feet** to an iron pin found;

Thence, south 17 degrees – 04 minutes – 25 seconds east, 23.24 feet to the *point of beginning*, and containing 0.077 acres more or less.

Subject to all legal highways and easements, whether recorded or implied.

Iron pins set are 5/8 rebar with yellow identification cap (FINLEY S-7222).

Bearings described herein are based on assumed azimuth and to be used for angle purposes only.

Being part of Auditor's Parcel #51-31-02-53-001.

Not to be used as a separate building site or transferred as an independent parcel in the future without Planning Commission approval in accordance with applicable subdivision regulations.

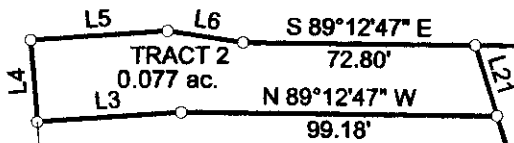
