thence leaving the south line of Shimoda Lane North 43 degrees 07 minutes 26 seconds East 118,68 feet to an iron pin found on the north line of Shimoda Lane;

thence along the north line of Shimoda Lane North 68 degrees 02 minutes 27 seconds East 92.10 feet to an iron pin found;

thence continuing along the north line of Shimoda Lane North 68 degrees 02 minutes 27 seconds East 28.12 feet to an iron pin set, the principle place of beginning for the following described parcel;

thence leaving the north line of Shimoda Lane North 09 degrees 38 minutes 58 seconds West 156.49 feet to an iron pin set;

thence North 70 degrees 12 minutes 57 seconds East 337.30 feet to an iron pin set on the west line of Eber Opdyke (DR 864-27);

thence along the west line of Eber Opdyke South 16 degrees 45 minutes 11 seconds East 132.95 feet to an iron pin found on the north line of Lectric Lane (50' wide);

thence along the North line of Lectric Lane the following three courses:

- South 70 degrees 12 minutes 57 seconds West 245,28 feet to an iron pin found;
- A curve to the left having a radius of 187.26 feet, South 57 degrees 35 minutes 58 seconds West a chord distance of 93.81 feet to an iron pin set;
- South 68 degrees 02 minutes 27 seconds West 21.00 feet to the principle place of beginning, containing 1.08 acres, more or less.

Subject to a 15' wide ingress/egress easement along the west property line of the above described parcel.






