DESCRIPTION OF SURVEY FOR EBER OPDYKE, JR.

Being part of the Quarter Township #3, Township #1, Range #6, of the US Military District, **being part of** the Eber Opdyke, Jr. property described in deed roference Deed Book Volume 521, Page 12 of said county's deed records, further known as Muskingum County Auditor's Parcel Number 51-31-02-53-000, and more particularly described as follows;

Commencing at an iron pipe (found) at the Northeast corner of Lot #8 of Shibui Acres recorded in Plat Book 13, Page 90; THENCE along a curve to the right heving a radius of 75.00 feet, an arc length of 24.75 feet, and a chord bearing of North 49 degrees 56 minutes 40 seconds East for a distance of 24.64 feet along the Northern Right of way of Shimoda Lane (Township Road #1591) as platted in said Shibui Acres end as shown on the plat of Durbin Heights No. 2 recorded in Plat Book 15, Pege 47, to an iron pin (found) at the place of beginning for the property herein intended to be described, said pin also being, the Northeest corner of said Shibui Acres, in the center of a gravel drive, common corner for said Opdyke property end for the V Riggle property recorded in deed reference Official Record Volume 1510, page 828, and in the center line of a 40 foot wide eesement;

- #1- THENCE North 75 degrees 49 minutes 20 seconds West for a distance of 67.25 feet along the common line for said Opdyke and Riggle properties, conter line of said 40 foot wide easement and North line of said Shibui Acres to an iron pin (found) in said gravel drive at a common corner for said Opdyke and Riggle properties;
- #2- THENCE North 08 degrees 15 minutes 40 seconds East for a distance of 35.30 feet leaving said easement and gravel drive and along a common line for said Opdyke and Riggle properties to an iron pin (set replacing an iron pin found disturbed) at a common corner for said Opdyke and Riggle properties and for the V Bednarczuk property recorded in deed reference Deed Book Volume 1131, Page 535;
- **#3- THENCE North 03 degrees 58 minutes 20 seconds West for a distance of 355.80 feet** along the common line for said Opdyke and Bednarczuk properties to the center of Little Salt Creek, being a common corner for said Opdyke and Bednarczuk properties and for a second Eber Opdyke, Jr. property recorded in deed reference Deed Book Volume 527, Page 726, passing iron pins (found) at 144.97 feet and 338.91 feat;
- #4- THENCE South 32 degrees 21 minutes 00 seconds East for a distance of 256.90 feet leaving said creek and through said Opdyke property to a pin-set, passing en iron pin (set) at 36.43 feet;
- #5- THENCE South 81 degrees 37 minutes 20 seconds East for a distance of 123.93 feet continuing through said Opdyke property to an iron pin (set);
- #6- THENCE South 17 degrees 40 minutes 50 seconds East for a distance of 157.02 feet continuing through said Opdyke property to an iron pin (set) on the Northern right of way for said Shimode Lane, passing an iron pin (set) at 143.67 feet;
- #7- THENCE South 67 degrees 57 minutes 30 seconds West for a distance of 82.97 feet along said Northern right of way, but crossing the existing roadbed for said Shimoda Lane to a mag-nail (set) in the Southern edge of pavement for said existing roadbed;
- #8- THENCE along a curve to the right having a radius of 25.00 feet, an arc length of 15.81 feet, and a chord bearing of South 86 degrees 03 minutes 50 seconds West for a distance of 15.55 feet for said Northern right of way to a mag-nail (set) in the Southern edge of said roadbed;

- #9- THENCE North 75 degrees 49 minutes 20 seconds West for a distance of 76.35 feet continuing along said Northern right of way, but crossing said roadbed to an iron pin (set);
- #10- THENCE along a curve to the left having a radius of 75.00 feet, an arc length of 58.62 feet, a chord bearing of South 81 degrees 47 minutes 20 seconds West for a distance of 57.13 feet for said Northern right of way to the place of beginning, containing 1.40 acres.

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
