

Situated in the State of Dhio, County of Muskingum, Township of Perry, Third Quarter, of Township #1, Range #6 of the US Military District;

Being a part of the prior deed reference Volume 521, Page 12 and Volume 864, Page 27 of the Muskingum County deed records, also being a part of the Muskingum County Auditor's Parcel Numbers (51-51-31-02-53-000), covering said Volume 521, Page 12, and (51-51-31-02-55-000), covering said Volume 864, Page 27 and is more particularly described as follows;

Commencing at an iron pin (found) at the Northeast corner of Lot C of Durbins Height No. 2 as recorded in Plat Book 15, Page 47; thence along the South right of way of Shimoda Lane as shown on said plat of Durbin Heights N 68 02 27 E 150.00 feet to change in right-of-way width; thence crossing said Shimoda Lane N 43 07 26 E 118.68 feet to an iron pin (found) at the Southeast corner of the property described in deed reference Volume 883. Page 289 and on the North right of way of said Shimoda Lane; thence along the North line of Shimoda Lane and South line of the property described in deed reference Volume 1010, Page 207 N 68 02 27 E 92.07 feet to an iron pin (found) at the Southeast corner of said Volume 1010, Page 207 and is the place of beginning for the property herein intended to be described;

- thence along the East line of said Volume 1010, Page 207 N 14 44 47 W 367.39 feet to an iron pin (found) at the Northeast corner of said Volume 1010, Page 207;
- thence through said prior deed reference Volume 521, Page 12 42-N 49 27 25 E 90.00 feet to the center of Little Salt Creek passing an iron pin (set) at 70.00 feet;
- thence along the center of said creek \$ 80 20 26 E 171.73 feet to a point from which an iron pin (set) for reference #3bears 5 00 24 16 E 23.00 feet;
- thence continuing along the center of said creek and passing **44**into prior deed reference Volume 864, Page 27 N 82 33 38 E 121.91 feet:

- thence leaving said creek and continuing through said Volume 864, Page 27 S 16 47 42 E 287.98 feet to an iron pin (found) at the Southwest corner of the property described in deed #6-reference 803, Page 202, and on the North line of Lectric Lane (Township Road #1432), passing an iron pin (set) at 36.77 feet; thence along the North line of said Lectric Lane S 70 43 25 W

- thence continuing along the North line of said Lectric Lane and with a curve to the left having, a Radius of 187.26 feet, an Arc Length of 94.82 feet, and a Chord Bearing S 56 13 05 W **48**-93.81 feet to an iron pin (set) on the North line of said Shimoda Lane;
- 49thence along the North line of said Shimoda Lame $\,$ 5 68 02 27 μ 49.12 feet to the place of beginning containing 1.899 acres from prior deed reference Volume 521, Page 12, and 0.900 acres from prior deed reference Volume 864, Page 27, for a total of 2.799 acres.

The bearings within this description are based on true North derived from a Solar Observation (Local Hour Angle Method) taken on the property. Iron pins (set) are 5/8" rebar with aluminum identification caps (C R Harkness R S 6885).
