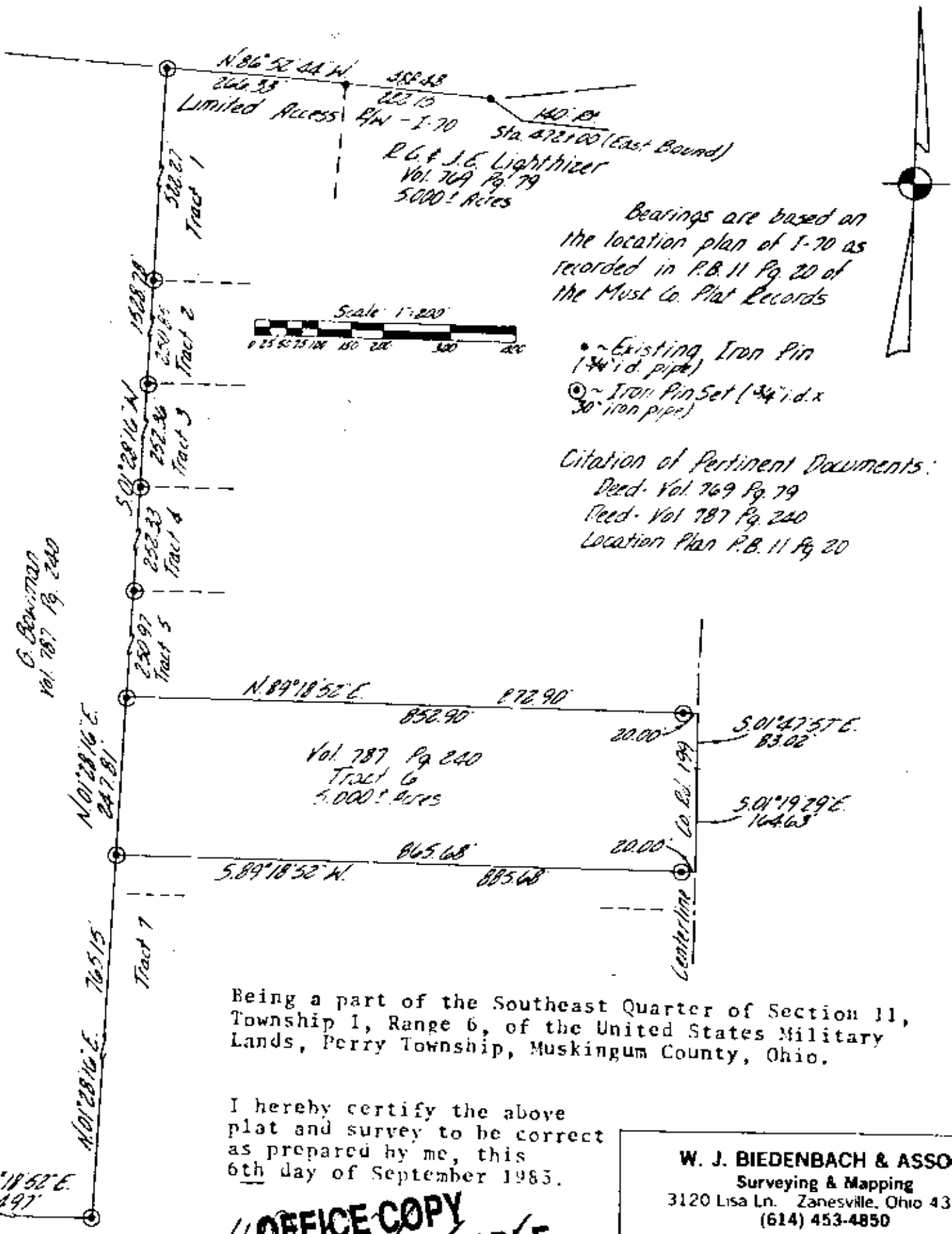
Commencing at the Southwest Corner of the Southeast Quarter of Section
