DRED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Perry, T-1, R-6, being a part of Christopher Paul Zemba Vol. 1104 Pg. 210, being part of the Southeast Quarter of Section 11, and more particularly described as follows:

Beginning at an iron pin found at the Southeast Corner of Section 11; thence along the East line of Section 11 North 02 Degrees 19 Minutes 05 Seconds West 1194.15 feet to an iron pin found and the place of beginning; thence leaving said East line South 88 Degrees 47 Minutes 30 Seconds West 1094.19 feet to a point in the centerline of Co. Rd. 199, passing iron pins found at 730.86 feet and at 1078.56 feet; thence along said centerline North 00 Degrees 29 Minutes 13 Seconds East 320.93 feet to a point in said centerline; thence leaving said centerline North 88 Degrees 47 Minutes 30 Seconds East 1078.48 feet to an iron pin set on the East line of Section 11, passing an iron pin set at 15.00 feet; thence along said line South 02 Degrees 19 Minutes 05 Seconds East 320.85 feet to the place of beginning, containing 8.00 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the East line of Section 11 as being South 02 Degrees 19 Minutes 05 Seconds East.


