Situated in the State of Ohio, County of Muskingum, Township of Perry, bounded and described as follows:

Being a part of Quarter Township 3, Township 1 North, Range 6 West, United States Military Lands and also being a part of lands now owned by Litle Family Partnership (DR 1076-156); being more particularly described as follows:

**TRACT TWO:** Beginning for reference at a point 172.53 feet right of Interstate 70 centerline station 231+64.27 as designated and delineated on Muskingum County Plat Book 10, Page 58, from which an iron pipe found bears North 26 degrees 06 minutes 35 seconds West 0.47 feet;

thence along the south right of way of Interstate 70 North 60 degrees 09 minutes 32 seconds East 118.35 feet to an iron pin found;

thence through lands now owned by Litle Family Partnership (DR 1076-156) and Buckeye Motor Lodge, Inc. (DR 530-772) the following six courses:

- 1) South 29 degrees 58 minutes 28 seconds East 201.52 feet to an iron pin found;
- 2) North 60 degrees 15 minutes 27 seconds East 147.21 feet to an iron pin found;
- 3) South 37 degrees 32 minutes 58 seconds East 39.95 feet to an iron pin found:
- South 20 degrees 11 minutes 14 seconds East 84.92 feet to an iron pin found;
- 5) South 08 degrees 34 minutes 23 seconds East 159.38 feet to an iron pin found;
- 6) South 14 degrees 09 minutes 31 seconds East 132.68 feet to an iron pin found on the north right of way of US Routes 40/22 and the principal place of beginning;

thence along said north right of way of US Routes 40/22 South 59 degrees 43 minutes 51 seconds. West 115.00 feet to an iron pin set;

thence through lands now owned by Litle Family Partnership (DR 1076-156) North 26 degrees 03 minutes 09 seconds West 120.89 feet to an iron pin set;

thence through said Little Family Partnership lands North 56 degrees 57 minutes 48 seconds East 114.45 feet to a point on the east line of said Little Family Partnership lands;

thence along said Little Familty Partnership lands cast line South 26 degrees 32 minutes 44 seconds East 126.36 feet to the principal place of beginning;

containing 0.33 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

**TRACT FOUR:** Beginning at a point 172.53 feet right of Interstate 70 centerline station 231+64.27 as designated and delineated on Muskingum County Plat Book 10, Page 58, from which an iron pipe found bears North 26 degrees 06 minutes 35 seconds West 0.47 feet;

thence along the south right of way of Interstate 70 North 60 degrees 09 minutes 32 seconds East 118.35 feet to an iron pin found;

thence continuing along said south right of way North 60 degrees 09 minutes 32 seconds East 515.84 feet to an iron pin found on the north line of Quarter Township 3;

thence along said north line of Quarter Township 3 and the north line of lands now owned by the Buckeye Motor Lodge, Inc. (DR 530-772), North 88 degrees 25 minutes 06 seconds East 212.31 feet to a point and the principal place of beginning;

thence along the north line of lands now owned by Litle Family Partnership (DR 1076-156), North 88 degrees 25 minutes 06 seconds East 122.75 feet to an iron pin found, passing an iron pin found at 52.69 feet;

thence through said Litle Family Partnership lands the following two courses:

- South 30 degrees 02 minutes 23 seconds East 130.46 feet to an iron pin found; 1)
- South 60 degrees 11 minutes 08 seconds West 131.02 feet to a point on the west line of said 2) Litle Family Partnership lands;

thence along the west line of said Litle Family Partnership lands North 23 degrees 02 minutes 56 seconds West 189.85 feet to the principal place of beginning;

containing 0.45 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.

Bearings are based on the centerline survey of Interstate 70 between Stations 235+00 and 242+15 as bearing North 60 degrees 50 minutes 21 seconds East as depicted on 1962 Centerline Survey as recorded in Muskingum County Plat Book 10, Page 58.
