ALL OF AUDITORS PARCEL
51-62-01-47-000 (4.322 Acres)

Situated in Quarter Township 3, T-1-N, R-6-W, U.S.M.L., Perry Township,
Muskingum County, Ohio.

Commencing at the center of Quarter Township 3; thence, **S.88°45'23"W.** a
distance of 2,754.10 feet to a point on the Northwest corner of the lands of
The Hicks Family Trust (2114/147); thence, **S.01°25'47"E.** a distance of 550.12
feet along the West line of said Hicks lands to a found iron pin, BEING THE
POINT OF BEGINNING;

Thence, **S.01°25'47"E.** a distance of **211.90 feet** along said Hicks lands to a
found iron pin on the Northeast corner of the lands, now or formerly,
owned by J. Berman (957/89);

Thence, **S.89°59'36"W.** a distance of **1,077.35 feet** along said Berman lands
to a set rebar on the East side of Hicks Road;

Thence, **N.01°20'11"W.** a distance of **112.00 feet** along the east side of said
road to a found iron pin on the Southwest corner of the lands, now or
formerly, owned by R. Kussmaul (2035/ 30 & 31);

Thence, **N.89°59'44"E.** a distance of **400.15 feet** along said Kussmaul lands to
a set rebar;

Thence, **N.01°20'11"W.** a distance of **100.00 feet** along said Kussmaul lands to
a set rebar on the South line of the lands, now or formerly, owned by
J. & B. Harris (1875/241);

Thence, **S.89°59'55"E.** a distance of **676.85 feet** along said Harris lands and
along the lands of N. & L. Baum (1818/68) to the point of beginning.

30" rebars with plastic I.D. caps. North is based upon an assumed meridian.




NORTH IS BASED UPON

SCALE 1" = 200'


